Dear Commissioner Ann Ravel:

Thank you for your very stewardly invitation for comments on the influence of money in our United States election.

The influence of money, both foreign and domestic, on elections in the United States must be restricted to protect our citizens' vote at federal, state and local levels. The Federal Election Commission's job is to assure an absolute equality of each and every citizen's vote.

Each citizen has the right to one vote, and only one vote, in an election. Citizens, individually, have a right to support candidates and propositions of their choice up to a monetary limit set by law. No citizen should gain a larger vote or more votes than another citizen by filing corporate papers.

Citizens, not corporations or organizations, are the voting unit in the United States. Therefore, corporations and foreign individuals, organizations, and governments must be prohibited from any and all contributions to politicians or election funds, in both primary and general elections.

Our government properly limits the monetary free speech of citizens in elections, thus our government can prohibit monetary free speech of non-citizens in elections. Citizens United must be overturned, because it has allowed corporations, foreign organizations, and foreign governments to make overtly political donations.
