<u>To</u>:

"The Board reviews and approves expenditures. The members select officers, and may approve or disapprove certain actions undertaken by the Board."

MOVED to approve draft Advisory Opinion 2009-29, as set forth in Agenda Document No. 10-03, subject to the amendment noted above, and to authorize the Office of General Counsel to make any necessary technical and conforming amendments.
