Chairman Petersen recognized Mr. David Adkins of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Commission regulations to disbursements by the Nevada State Democratic Party for campaign materials to be used in connection with volunteer activities on behalf of candidates for Federal office before the 2010 Nevada primary election. A discussion followed.

On Page 5, Lines 11-16, delete the sentence which begins with the phrase "By contrast," and ends with the word "election" and replace it with the following language:

"By contrast, payments made by the State Party, for materials that are used in connection with volunteer activities on behalf of candidates, will not qualify for the volunteer materials exemption if those activities take place before March 12, 2010."
