Federal Election Commission Minutes of an Open Meeting October 7, 2010

Chairman Matthew S. Petersen called the Federal Election Commission to order in an open meeting at 10:12 A.M. on Thursday, October 7, 2010, with a quorum present.

Chairman Petersen noted that the Draft Notice of Proposed Rulemaking on Independent Expenditures and Electioneering Communications by Corporations and Labor Organizations, originally scheduled to be discussed at this meeting, would be held over to the next public meeting.

Chairman Petersen recognized Vice Chair Bauerly who

MOVED to suspend the rules on the timely submission of agenda documents in order to consider Agenda Documents No. 10-61-C, No. 10-61-D, No. 10-62, No. 10-63, No. 10-63-A, and No. 10-63-B. <u>The motion carried on a vote of 6-0</u> with Commissioners Bauerly, Hunter, McGahn, Petersen, Walther and Weintraub voting affirmatively for the decision.

Chairman Petersen recognized Mr. Tony Buckley of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Commission regulations to Google Inc.'s proposal to sell text ads to candidates, their authorized committees, and other political committees, and whether disclaimers are required on text ads generated when Internet users use Google's search engine to perform searches. A discussion followed.

Chairman Petersen recognized Theodore Lutz of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Commission regulations to a proposed program under which ReCellular would transmit to political committees contributions from consumers resulting from the sale of used cell phones to ReCellular.

Chairman Petersen recognized Vice Chair Bauerly who

MOVED to adopt Agenda Document No. 10-62, the Advisory Opinion 2010-21 for ReCellular.

<u>The motion carried on a vote of 6-0</u> with Commissioners Bauerly, Hunter, McGahn, Petersen, Walther and Weintraub voting affirmatively for the decision.

The Chairman noted that counsel, Lee Goodman, was present to answer any questions the Commission may have during the discussion.

Chairman Petersen recognized Peter Reynolds of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Commission regulations to whether RG Entertainment's ("RGE") disbursements to produce, distribute, and advertise the documentary film I WANT YOUR MONEY (the "Film") are expenditures or electioneering communications; whether RGE's production and distribution of the Film would be a coordinated communication with Ms. Parker; whether a licensee's payment of the cost of screening the Film would be a contribution to Ms. Parker's authorized committee; and whether Ms. Parker's use of her personal funds to license a promotional screening of the Film would be an independent expenditure. A discussion followed.

Chairman Petersen recognized Commissioner Hunter who

MOVED to approve Agenda Document No. 10-63-B, Revised Draft B.

<u>The motion failed on a vote of 3-3</u> with Commissioners Hunter, McGahn and Petersen voting affirmatively for the motion. Commissioners Bauerly, Walther and Weintraub dissented.

Chairman Petersen recognized Commissioner Bauerly who

MOVED to approve Agenda Document No. 10-63-A, Revised Draft A.

<u>The motion failed on a vote of 3-3</u> with Commissioners Bauerly, Walther and Weintraub voting affirmatively for the motion. Commissioners Hunter, McGahn and Petersen dissented. Federal Election Commission Minutes of an Open Meeting October 7, 2010

Chairman Petersen instructed the Office of General Counsel to prepare a draft that addresses the four areas of agreement between these two drafts. He also outlined the three areas in which there was not agreement between the drafts. Chairman Petersen noted that the Advisory Opinion Request is under expedited review and instructed the General Counsel to circulate the draft on an abbreviated tally vote basis, if necessary, by Tuesday, October 12.
