**III. DRAFT ADVISORY OPINION 2013-11**

**Citizens for Joe Miller by William J. Olson, Esq.**

**Chair Weintraub recognized Commissioner Petersen who**

**MOVED to suspend the rules on the timely submission of agenda documents in order to consider Agenda Document No. 13-41, Draft Advisory Opinion 2013-11.**

**The motion carried by a vote of 6-0 with Commissioners Goodman, Hunter, Petersen, Ravel, Walther, and Weintraub voting affirmatively for the decision.**

**Chair Weintraub recognized Ms. Cheryl Hemsley of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to the request. Citizens for Joe Miller asks whether it may use campaign funds to post a cash deposit in lieu of a supersedeas bond on appeal from an Alaska court judgment against former Senate candidate Joseph Miller and/or to pay the final judgment should Mr.**

**Miller be unsuccessful on his appeal. She also asked for authority to make any technical and conforming amendments if necessary.**

**Chair Weintraub recognized requestor's counsel, Mr. William Olson, who was available to answer Commissioners' questions.**

**Mr. Olson and Mr. Adav Noti of the General Counsel's Office participated in the discussion that followed.**
