**III. DRAFT INTERPRETIVE RULE ON REPORTING ULTIMATE  
PAYEES OF POLITICAL COMMITTEE DISBURSEMENTS**

**Chair Weintraub recognized Mr. Neven Stipanovic of the General  
Counsel's Office who summarized the two alternative Draft Notices. The  
Draft Notices set forth the Commission's interpretation on the requirement  
that political committees report the full name and address of each person  
to whom they make disbursements aggregating more than \$200 per  
calendar year or per election cycle for authorized committees, and the  
date, amount, and purpose of such payments. This interpretation applies to**

**three specific factual situations: (1) when a political committee reimburses an individual who advances personal funds to pay committee expenses aggregating more than \$200 to a single vendor; (2) when a political committee pays a credit card bill that includes a charge of more than \$200 for a single vendor; and (3) when a candidate uses personal funds to pay his or her authorized committee's expenses that aggregate more than \$200 to a single vendor without receiving reimbursement. The Drafts differ as to when the interpretation for a candidate's use of personal funds is effective. He asked that the Commission authorize technical and conforming amendments if the Draft Notice is approved.**

**Chair Weintraub said that, while the substantive discussion on the  
OGC Enforcement Manual would occur at a future meeting, she wanted to  
provide some background information for these documents. Agenda  
Document No. 13-21 is the Enforcement Manual prepared by the Office of  
General Counsel in January 2013. Agenda Document No. 13-21-A, prepared  
by Vice Chairman McGahn and Commissioners Hunter and Petersen, is  
similar to the Enforcement Manual (Agenda Document No. 13-21), but it  
contains a number of proposed edits to that Manual. Agenda Document No.  
13-21-B is a revision of Agenda Document 13-21 and incorporates some of**

**the edits from the Manual proposed by Vice Chairman McGahn and Commissioners Hunter and Petersen (Agenda Document No. 13-21-A).**

**The Chair also noted that two overarching topics will be discussed: (1) what happens at the pre-reason to believe phase and what types of documents the staff in the Office of General Counsel should look at when formulating their recommendations; and (2) what should be the Commission's relationship with the Department of Justice. The remaining documents mostly reflect the history of how these issues were handled in the past and contain recommendations for how they should be handled in the future.**

**Chair Weintraub said that the General Counsel's Office is currently following the procedures set forth in Agenda Document No. 13-21-B.**
