**ActBlue by Stephen Gold, Esq., General Counsel**

**Chairman Goodman recognized Mr. Gold and Ms. Melissa Flores, the  
requestor's counsel, who were present to answer Commissioners' questions.**

**Chairman Goodman recognized Mr. Neven Stipanovic of the General  
Counsel's Office who presented the draft advisory opinion concerning the  
application of the Federal Election Campaign Act of 1971, as amended, and  
Commission regulations to ActBlue's request concerning its contribution  
forms through which contributions may be made on its website. ActBlue, a  
registered nonconnected political committee, receives earmarked**

**contributions through its website and forwards them to designated candidates and political committees. ActBlue's users can configure these forms to allow contributions to be made to multiple committees at one time. Such multiple-recipient forms include a box labeled "Split It!" that allows a contributor to enter a single contribution amount and split the amount among the recipient committees. ActBlue asks two questions concerning the use of the "Split It!" box: 1) does use of the box result in ActBlue exercising direction or control over the contributions; and 2) does use of the box subject the activity to the joint fundraising rules. Mr. Stipanovic asked for authority to make any necessary technical and conforming changes if the Commission approves the Draft.**

**MOVED to approve Agenda Document No. 14-44 subject to the edits proposed by Chairman Goodman at the table and authorize the Office of the General Counsel to make any necessary technical and conforming edits.**


