- 9 Part 115 prohibits federal contractors from making contributions or expenditures to any political
- party, political committee, or federal candidate, or to any person for any political purpose or use.
- 11 11 CFR 115.2(a); see also 52 U.S.C. 30119(a)(1) (formerly 2 U.S.C. 441c(a)(1)). Part 115
- 12 further prohibits any person from knowingly soliciting a contribution from any federal
- 13 contractor. 11 CFR 115.2(c); see also 52 U.S.C. 30119(a)(2) (formerly 2 U.S.C. 441c(a)(2)).
- 14 The petitioner asks the Commission to amend 11 CFR part 115 to include certain factors for
- determining whether entities of the same corporate family are distinct business entities for
- purposes of these prohibitions. The Commission seeks comments on the petition.
