**II. DRAFT ADVISORY OPINION 2016-04**

**Grand Trunk Western Railroad Co. – Illinois Central  
Railroad Co. Political Action Committee

**Chairman Petersen recognized Mr. Barron, requestor's counsel, who was available to answer Commissioners' questions.**

**Chairman Petersen recognized Ms. Esther Gyory of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and the Commission regulations to the request. The Grand Trunk Western Railroad Co. – Illinois Central Railroad Co. Political Action Committee ("PAC") is a separate segregated fund of two subsidiary corporations of the parent corporation, Canadian National Railway Company. Canadian National Railway Company and its subsidiaries collectively operate under the brand "CN". The PAC asks whether it may use "CN" in its abbreviated name.**

**Mr. Barron and Mr. Adav Noti of the General Counsel's Office also participated in the discussion that followed.**

**Chairman Petersen recognized Commissioner Hunter who**

**Chairman Petersen stated that this matter will be held over to the next open meeting; however, Commissioner Weintraub would like to present her new document.**

**Chairman Petersen recognized Commissioner Weintraub who thanked Commissioners Goodman and Ravel for all of their work on their proposals to expand the number and kind of documents put on the public record.**

**Commissioner Weintraub stated that because there are large areas of agreement, her document attempts to synthesize their suggestions with the Commission's**

**interim disclosure policy and put it into a single, permanent policy. She noted that it will be useful to the public to have one document which explains what will be put on the public record, and she looks forward to her colleagues' comments.**

**Chairman Petersen recognized Commissioner Ravel who welcomed Commissioner Weintraub's suggestion and thinks that the Commission should take a broad, holistic approach and adopt a permanent policy.**

**Chairman Petersen recognized Commissioner Goodman who stated that he believes the Commission is on a constructive course and thanked Commissioners Ravel and Weintraub for working with him on this matter.**

**V. REG 2014-01 OUTLINE OF DRAFT NPRM IMPLEMENTING PARTY SEGREGATED ACCOUNTS**

**Agenda Document No. 15-54-B**

**Chairman Petersen recognized Commissioner Weintraub who expressed her concern about the lack of Commission action involving these new accounts set up under "Cromnibus" at the end of 2014. She explained that although the General Counsel's Office prepared a detailed outline in October, 2015 about how to move forward with a rulemaking and the Commission discussed this matter in December, the Commission has taken no further action. She stated that the Commission needs to provide guidance to party committees, donors, and others about how to move forward using these new accounts and recommends that the**

**General Counsel's Office be directed to begin drafting a rulemaking incorporating any Commissioners' alternatives.**

**Discussion followed.**

**Chairman Petersen stated that he will re-review the outline prepared by the General Counsel's Office, then consult with his colleagues about any necessary modifications to the outline. He added that he was hopeful a decision on the outline could be reached shortly so that the General Counsel's Counsel can begin to draft a rulemaking.**
