Chairman Matthew S. Petersen called the Federal Election Commission to order in an open meeting at 10:32 A.M. on Thursday, October 27, 2016 with a quorum present.

Chairman Petersen recognized Vice Chairman Walther who

Citizen Super PAC by Chris K. Gober, Esq. and Troy A. McCurry, Esq.

Chairman Petersen recognized Mr. Troy McCurry, requestor's counsel, who was available to answer Commissioners' questions.

Chairman Petersen recognized Ms. Jessica Selinkoff who presented the draft advisory opinion concerning the application of the Federal Election

Campaign Act of 1971, as amended, and the Commission regulations to the request. Requestor, an independent expenditures-only political committee, asks questions regarding its proposed distribution of a public communication expressly advocating the election of a candidate after contacting that candidate's authorized committee to request certain support for the communication. Ms.

Selinkoff summarized the differences between the two drafts.

Chairman Petersen stated that because of the confusion reflected in both drafts regarding the nature of the questions being asked, this matter will be discussed but not resolved today. Because the next open meeting is scheduled to occur after the election, he stated that this matter may be resolved on tally prior to that date.
