Page 9, Line 4: Replace "(a)(2)(i)
and (ii) " with "(a)(2)(i),(ii) and (iv)";

Page 27, Line 8: Delete "and";

Page 27, Line 12: Insert "and" after
"practice";

Page 27, after Line 12: Insert
"(iv) Whether the person leasing the
mailing list actually uses the list."

It was agreed without objection to accept the amendments.

"The Commission also seeks comment on whether a candidate may acquire personal ownership of a list in other ways. example, a candidate may sign a fundraising appeal for an organization other than his or her principal campaign committee and receive the use of responsive names, in compliance with Commission regulations. Should the use of the list be viewed as a property interest of the candidate's principal campaign committee, the candidate personally, or both? How significant to that determination are the terms of an agreement purporting to confer a property interest on the principal campaign committee, the candidate personally, or both?"

Chair Weintraub recognized Ms. Rosemary Smith of the General Counsel's Office who offered an amendment to Agenda Document No. 03-66-A, Page 2, No. 9, as follows:

Delete the words "political committee" and replace with the word "entity."
