

GENERAL COUNSEL'S REPORT

I. BACKGROUND

The respondent contributor was referred to the Office of General Counsel for a possible violation of 2 U.S.C. §441a (a) (3) which prohibits aggregate contributions by an individual in excess of \$25,000 in any calendar year. On November 16, 1979, the Commission voted to defer action on the matter pending receipt and analysis by this office of new information from the Reports Analysis Division.

II. EVIDENCE/ANALYSIS

On November 23, 1979, this office received a referral update from RAD. This update included 1977 and 1979 contributions made by a Laurance Rockefeller to the principal campaign committees of candidates running for election in 1978 and, in accordance with the Act, are considered as having been made during calendar year 1978.

However, due to the fact that Laurance S. Rockefeller has a son of the same name, who has apparently also made contributions, it was determined that a further review of the G index and the various committee reports was needed. The review

indicates the following: There is one contribution where "Jr." follows the name Laurance Rockefeller listing the contributor's place of business as the Natural Resources Defense Council (NRDC). Therefore, it may reasonably be assumed that the Laurance Rockefeller contributions listing NRDC as the contributor's principal place of business are attributable to the son rather than the father. The total of these contributions apparently attributable to him is \$7,600.00, bringing Laurance Rockefeller, Sr.'s maximum total of 1978 contributions to no more than \$21,850.00. In view of these facts, the Office of General Counsel recommends the Commission take no action in this matter and close the file.

GENERAL COUNSEL'S REPORT

I. BACKGROUND

This matter involves a possible violation of §441a(a)(3) by the respondent contributor. On November 16, 1979, the Commission voted to defer action on the matter pending receipt and analysis by the Office of General Counsel of new information from the Reports Analysis Division (RAD).

II. EVIDENCE/ANALYSIS


On November 23, 1979, this office received a referral update from RAD. This update included 1977 and 1979 contributions made by the respondent to the principal campaign committees of candidates running for election in 1978 and, in accordance with the Act, are considered as having been made during calendar year 1978. See also Section 110.5(b) of the Regulations.

According to Section I of the G Index, Mr. Rockefeller made a total of \$29,450.00 in contributions for 1978. (See the attached referral and referral update for specific recipients, dates and amounts.) Therefore, it appears that the respondent may have violated 2 U.S.C. §441a(a)(3) which prohibits an individual from making contributions aggregating in excess of \$25,000 in a calendar year.

III. RECOMMENDATION

1. Find reason to believe that Laurance S. Rockefeller may have violated 2 U.S.C. §441a(a)(3).
2. Send the attached letter.

This section of the Act makes it unlawful for any individual to make contributions to federal elections aggregating in excess of \$25,000 in a calendar year. Specifically it appears that you have made contributions totalling \$29,450.00. Please note that this total includes contributions made in 1977 and 1979 which were given to candidates running for election during 1978 and therefore are attributable to 1978. See also section 110.5 of the Commission's Regulations, 11 C.F.R. §110.5. Please see the attached sheets detailing your contributions. The dates used indicate the receipt date by the committees.

We have numbered this matter MUR 1061. Please refer to this number in all future correspondence.

Under the Act, you have an opportunity to demonstrate that no action should be taken against you. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Where appropriate, statements should be submitted under oath.

The Commission is under a duty to investigate this matter and your response should be submitted within ten days after receipt of this notification. If no response is received, the Commission may take further action based on the information at hand.

GENERATION OF MATTER

This matter was one of a number of similar matters referred to this office by the Reports Analysis Division on October 22, 1979. The matter involves a possible violation of 2 U.S.C. §441a(a)(3) by the respondent contributor.

BACKGROUND

Section 441a(a)(3) of the Act prohibits aggregate contributions by an individual in excess of \$25,000 in any calendar year. The Act and §110.5 of the Regulations also provide that non-election year contributions made to a principal, authorized or single campaign committee, or independent expenditures made, and designated for an election, shall count against the \$25,000 limit.

The RAD referral included contributor information about this respondent for 1978 only. Consistent with the Act and the Regulations, we requested RAD to supplement its referral with information about 1977 and 1979 contributions. We expect to receive this information by November 13, 1979.

After this information is received and analyzed we will present a full report and recommendation to the Commission. We expect to make this presentation within two weeks.

RECOMMENDATION

Defer action on this matter pending receipt and analysis by Office of General Counsel of new information from Reports Analysis Division.
