

CONCILIATION AGREEMENT

This matter having been initiated by the Federal Election Commission (hereinafter "the Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities, and after reason to believe having been found that Lew R. Wasserman ("Respondent") violated 2 U.S.C. § 441a(a)(3) by making contributions in excess of \$25,000 for Federal elections in 1977 and 1979.

NOW, THEREFORE, the Commission and Respondent, having duly entered into conciliation pursuant to 2 U.S.C. § 437g(a)(4)(A)(i) do hereby agree as follows:

I. The Commission has jurisdiction over the Respondent and the subject matter of this proceeding.

II. Respondent has had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondent enters voluntarily into this Agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. According to reports filed with the Commission , Respondent made contributions totaling \$27,000 for Federal elections in 1977 and \$34,994 in 1979.

2. Mrs. Wasserman has filed a statement with the Commission asserting that the contributions were made out of the community property of Mr. and Mrs. Wasserman and constituted contributions equally from Respondent and Mrs. Wasserman.

3. Respondent's counsel alleges that since all contributions made by Mr. and Mrs. Wasserman are from community property, all contributions by Mr. and Mrs. Wasserman should be deemed made one-half by Mr. Wasserman and one-half by Mrs. Wasserman.

4. Respondent did not indicate on the relevant contribution checks or in accompanying written statements signed by Mr. and Mrs. Wasserman that one-half of the amounts of the contributions were to be attributed to Mrs. Wasserman, in accordance with 11 C.F.R. § 104.8(d) (formerly 11 C.F.R. § 104.5(e)).

WHEREFORE, Respondent agrees;

V. Respondent did not indicate on the relevant contribution checks or in accompanying written statements signed by respondent and his wife that one-half of the amounts of the contributions were to be attributed to Mrs. Wasserman, and thereby Respondent violated 2 U.S.C. § 441a(a)(3) by having contributions attributed to him totaling \$27,000 for Federal elections in 1977 and \$34,994 in 1979.

VI. Respondent alleges that such violation was not knowing and willful.

VII. Respondent will file a statement signed by him and Mrs. Wasserman with each committee to which he and Mrs. Wasserman made a contribution for a Federal election in 1977 and 1979 indicating their intent to have one-half of the amounts of the contributions attributed to respondent and one-half to Mrs. Wasserman.

VIII. Respondent will pay a civil penalty to the Treasurer of the United States in the amount of two hundred fifty dollars (\$250), pursuant to 2 U.S.C. § 437g(a)(6)(B).

GENERAL CONDITIONS

VIII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

IX. It is mutually agreed that this agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

X. It is mutually agreed that respondent shall comply with the requirements of Paragraphs VII and VIII of the agreement

within thirty (30) days from the date this agreement becomes effective.



GENERAL COUNSEL'S BRIEF

I. Statement of Case

On December 11, 1979, the Reports Analysis Division ("RAD") referred to the Office of General Counsel Mr. Lew R. Wasserman in connection with his possible violation of 2 U.S.C. § 441a(a)(3). RAD's referral was initiated by a review of the Commission's G Index which indicated that Mr. Wasserman's aggregate contributions to various party committees in 1977 and 1979 exceed the \$25,000 limitation. The subject contributions are listed separately below.

## II. Legal Analysis

As set forth in 2 U.S.C. § 441a(a)(3), "no individual shall make contributions aggregating more than \$25,000 in any calendar year."

A review of the Commission's G Index and reports filed by various party committees indicates that Mr. Wasserman contributed \$27,000 in 1977 and \$34,994 in 1979. Thus, the Commission, on February 4, 1980, found reason to believe that a violation of § 441a(a)(3) had been committed and so notified the respondent.

On February 15, 1980, Donald T. Rosenfeld, counsel for the respondent, filed a response to the Commission's reason to believe notification. In his response, counsel stated that "all funds from which [the] contributions were made were the community property of Mr. and Mrs. Wasserman," pursuant to Section 5105 of the California Civil Code.

Rosenfeld asserts that since all the Wasserman's assets are community property, fifty percent of each contribution is automatically from Mrs. Edith Wasserman and fifty percent is from Mr. Wasserman. However, pursuant to 11 C.F.R. § 104.8(c) (formerly § 104.5(c)),

Absent evidence to the contrary, any contribution made by check, money order, or other written instrument shall be reported as a contribution by the last person signing the instrument prior to delivery to the candidate or committee.

Additionally, 11 C.F.R. § 104.8(d), (formerly § 104.5(e)) elaborates further, requiring that,

A contribution which represents contributions by more than one person shall indicate on the written instrument, or on an accompanying written statement signed by all contributors, the amount to be attributed to each contributor.

Thus, for any contribution made through one instrument to be considered a contribution by both a husband and wife, both must sign either the instrument or accompanying writing specifying that each is a contributor and the amount to be attributed to each.

Therefore, regardless of the community property laws of California and absent evidence to the contrary, the contributions made by Lew Wasserman are attributed solely to him. Thus, the Commission's previous finding that a violation of § 441a(a)(3) has been committed by Mr. Wasserman is still valid and it is recommended that the Commission find probable cause to believe that such a violation has been committed.

Additionally, while Mrs. Wasserman has filed a statement with the Commission attributing 50% of the subject contributions to herself, written notifications must be filed with the recipient committees advising them of the proper attribution of each contribution.

### III. Recommendation

Find probable cause to believe that Lew Wasserman has violated 2 U.S.C. § 441a(a)(3).





INTERIM INVESTIGATIVE REPORT #1

On February 4, 1980, the Commission found reason to believe that Lew R. Wasserman violated 2 U.S.C. § 441a(a)(3). The Commission's determination was based on the G Index and reports filed by various party committees; those documents indicate that Wasserman contributed \$27,000 in 1977 and \$34,994 in 1979 in connection with federal elections.

Mr. Wasserman was advised of the Commission's reason to believe determination and sent a reason to believe notification on February 6, 1980. Counsel for the respondent replied to the Commission's notification on February 15, 1980, by stating that the subject contributions were made from community property assets of the Wassermans under California State Law.

The Office of General Counsel has written counsel requesting that he submit information in addition to that provided in his letter of February 15th. Upon receipt of his response, a further recommendation will be made to the Commission.



We represent Mr. and Mrs. Lew R. Wasserman; and I am writing to you on their behalf at the suggestion of Mr. Thomas Whitehead.

No violation by Mr. Wasserman of the Federal Election Campaign Act of 1971 has occurred because Mr. Wasserman made only one-half of all of the contributions in 1977 and 1979 which apparently were reported by the various Committees concerned as made solely by Mr. Wasserman. The other one-half of such contributions were made by his wife, Edith Wasserman.

All funds from which such contributions were made were the community property of Mr. and Mrs. Wasserman. (Mr. Wasserman has no separate property, that is, all of Mr. Wasserman's assets are the community property of Mr. and Mrs. Wasserman.) Because the subject contributions were derived entirely from community property, it is clear that only one-half of the total amount of each contribution is attributable to Mr. Wasserman and the other one-half is attributable to Mrs. Wasserman.

In accordance with Mr. Whitehead's suggestion, set forth below is the text of Section 5105 of the California Civil Code, our basic section on community property:

**§ 5105. Community property; Interests of parties**

"The respective interests of the husband and wife in community property during continuance of the marriage relation are present, existing and equal interests. This section shall be construed as defining the respective interests and rights of husband and wife in community property."


