GENERAL COUNSEL'S REPORT

I. BACKGROUND:

On February 23, 1983, the Commission considered the General Counsel's Report in this matter dated February 10, 1983. At the meeting, the Commission determined to reject the General Counsel's recommendation to find reason to believe that The Generation After, Inc. ("TGA") violated 2 U.S.C. § 441b(a) and to send interrogatories. Instead, the Commission adopted the first alternative presented in the Legal Analysis which was to take no action against the Ad Hoc Committee Against Nazism and Anti-Semitism and to find no reason to believe the Jewish War Veterans, Inc., The Generation After, Inc., Agudath Israel of America, Inc., and Rabbi Lubinsky violated the Act. However, the motion voted upon and passed by the Commission found no reason to believe that The Generation After, Inc. violated 2 U.S.C. § 441b(a) and to close the file. Therefore, the General Counsel recommends that the Commission make the additional determinations with respect to the other respondents at this time.



GENERAL COUNSEL'S REPORT

I. BACKGROUND:

On December 14, 1982, the Commission decided to send a letter to the complainant in this matter, Michele Steinberg, requesting further information concerning the respondents named in her complaint. Specifically, information was requested concerning the addresses of the Ad Hoc Committee Against Nazism and Anti-Semitism ("Ad Hoc Committee") and the Apple Press, Inc. The Commission deferred taking any action with respect to the other respondents until the complainant had an opportunity to provide further information. A letter was sent to the complainant requesting further information on December 16, 1982.

Attempts were made by the Office of General Counsel to reach Michele Steinberg by phone after a timely response was not received from her. On January 26, 1983, she returned the call. She stated that she had no other address for the Ad Hoc Committee other than the address listed on the anti-Klenetsky letter attached to her complaint. She stated that it was her allegation that The Generation After, Inc. was responsible for the anti-

Klenetsky letter. Additionally, she had no further information as to the location of the Apple Press, Inc.

II. LEGAL ANALYSIS

The Commission's December 16, 1982 inquiry to the complainant, Michele Steinberg, failed to obtain any further information as to the location of the Ad Hoc Committee and the Apple Press, Inc. Ms. Steinberg reiterated her allegation that the Ad Hoc Committee and The Generation After, Inc. ("TGA") are one organization. TGA has denied the allegation in its response to the filing of the complaint.

It appears that the Commission has two alternatives in this matter. The first alternative is to close the matter at this time by finding no reason to believe the Jewish War Veterans, Inc., Agudath Israel of America, Inc., Rabbi Lubinsky, and The Generation After, Inc. violated the Act (See Legal Analysis of First General Counsel's Report) and to take no action against the Ad Hoc Committee Against Nazism and Anti-Semitism based on the fact that it has not been notified of the filing of the complaint as required by 2 U.S.C. § 437g(a)(1). The second alternative would be to initiate an investigation by finding reason to believe TGA violated 2 U.S.C. § 441b(a) and sending interrogatories concerning the anti-Klenetsky letter. Action would be deferred with respect to the other respondents until TGA has submitted responses to the interrogatories.

The Office of General Counsel recommends that the Commission adopt the second alternative. This alternative would initiate an investigation by sending TGA interrogatories. Proposed interrogatories have been prepared and are attached for Commission approval.

III. RECOMMENDATIONS


1. Find reason to believe The Generation After, Inc. violated 2 U.S.C. § 441b(a) and send the attached interrogatories.

2. Defer taking any action with respect to the Ad Hoc Committee Against Nazism and Anti-Semitism; the Jewish War Veterans Inc., Agudath Israel of America, Inc., and Rabbi Lubinsky until The Generation After, Inc. files responses to the attached interrogatories.

Upon further review of the allegations contained in the complaint and information supplied by you, the Commission, on February , 1983, determined that there is reason to believe that The Generation After, Inc. violated 2 U.S.C. § 441b(a), a provision of the Act. You may submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Please submit answers to the enclosed questions within ten days of your receipt of this notification. Statements should be submitted under oath.

The Office of General Counsel would like to settle this matter through conciliation prior to a finding of probable cause; however, in the absence of any information which demonstrates that no further action should be taken against your committee, the Office of General Counsel must proceed to the next compliance stage as noted on page 2, paragraph 2 of the enclosed procedures.



SUMMARY OF ALLEGATIONS

On September 24, 1982, Michele Steinberg filed a complaint against the Ad Hoc Committee Against Nazism and Anti-Semitism; the Jewish War Veterans; The Generation After (a/k/a TGA, Inc.), Agudath Israel of America and Rabbi Menachem Lubinsky. Steinberg alleges various violations by these groups including but limited to 2 U.S.C. § 441b as to those respondents which are

incorporated, 2 U.S.C. § 435(b) as to those respondents which distributed campaign literature and did not fulfill the "campaign advertising requirements,"*/ and 2 U.S.C. § 433 as to all of the respondents for not registering with the Commission as political committees.

Submitted with the complaint was a copy of a letter printed by the Ad Hoc Committee Against Nazism and Anti-Semitism, a copy of a sticker saying "A Vote For A Nazi is A Vote For Klenetsky" and two letters written by The Generation After.

Copies of the complaint were forwarded to the five respondents on September 28, 1982. Responses were received from the Jewish War Veterans, Inc., Menachem Lubinsky, Agudath Israel of America, Inc., and The Generation After, Inc. The complaint which was sent to the Ad Hoc Committee Against Nazism and Anti-Semitism was returned marked "REFUSED."

FACTUAL AND LEGAL ANALYSIS

The Ad Hoc Committee Against Nazism and Anti-Semitism

The complaint alleges that the Ad Hoc Committee Against Nazism and Anti-Semitism ("Ad Hoc Committee") is a political committee and should therefore have registered and filed reports

*/ Former 2 U.S.C. § 435(b) was repealed in the 1979 amendments to the Federal Election Campaign Act, thus that provision has not been effective since January 8, 1980. Since the activity in this matter occurred after that time no violation of 2 U.S.C. § 435(b) could have occurred. However, although not specifically alleged, the disclaimer provisions of 2 U.S.C. § 441d and 11 C.F.R. § 110.11(a)(1)(iv) are applicable and will be considered in this report whenever the complainant makes a 2 U.S.C. § 435(b) allegation.

with the Commission. The complaint also alleges that a letter printed by the Ad Hoc Committee titled "Who Is Mel Klenetsky," failed to carry a proper disclaimer.

A copy of the complaint was forwarded to the Ad Hoc Committee at the address listed on the letter, Box 364 Baychester Station, New York, N.Y. 10469. This is also the address of The Generation After. The complaint was returned to the Commission marked "REFUSED." John Ranz of The Generation After stated that the complaint addressed to the Ad Hoc Committee was delivered to The Generation After's post office box and that he refused it because he did not know of the organization. He also stated that he had no knowledge of the author of the letter printed by the Ad Hoc Committee. The complaint was not resent as no other address was available.

The allegations set forth in the complaint present two issues. The first issue is whether the Ad Hoc Committee is a political committee. The second issue is whether the letter carried an appropriate disclaimer.

The Act requires that any organization which either receives contributions or makes expenditures aggregating in excess of \$1,000 during a calendar year must register and report with the Commission as a political committee. It appears from the complaint that the Ad Hoc Committee distributed a letter which was designed to influence the election of Mel Klenetsky. However, we have no information as to the cost of the letter,

i.e. whether the Ad Hoc Committee received contributions or made expenditures in excess of \$1,000.

With regard to the disclaimer issue, the letter is titled "Who Is Mel Klenetsky", it discusses an association between Klenetsky and LaRouche, and ends with the question "DO YOU STILL WANT TO VOTE FOR KLENETSKY?". Printed on the bottom in capital letters is the phrase "THE AD HOC COMMITTEE AGAINST NAZISM AND ANTI-SEMITISM" followed by what appears to be an incorrect address. 2 U.S.C. § 441d(a) requires that whenever a person makes an expenditure for the purpose of financing communications expressly advocating the election or defeat of a clearly identified candidate the communication must state who paid for it and whether it was authorized by any candidate or candidate's committee. See 11 C.F.R. § 110.11(a). Although a name and address was listed on the letter, the requirements of 2 U.S.C. § 441d were not complied with.

Because the Ad Hoc Committee has not been notified of the filing of the complaint (due to the Office of General Counsel not having a correct address) we are not making a reason to believe recommendation as to 2 U.S.C. §§ 433, 434 or 441d at this time. However, we are recommending that the Commission pursue this matter by attempting to locate the Ad Hoc Committee. One alternative that we thought might be fruitful to pursue was to contact Apple Press, Inc., a printer mentioned in the complaint. However, we can not locate an Apple Press, Inc. either through the telephone company or through the New York Secretary of State

Office. A second alternative, and the one which we recommend the Commission adopt, is to send a letter back to the complainant, Michele Steinberg, seeking any information which she might have as to the address of the Ad Hoc Committee and the Apple Press, Inc.

Jewish War Veterans ("JWV")

The complaint states that members of JWV were seen passing out the letter titled "Who Is Mel Klenetsky"; and that stickers saying "A VOTE FOR A NAZI IS A VOTE FOR KLENETSKY" were printed at the Apple Press, Inc., a printing company used by JWV. From this information it is alleged that a violation of 2 U.S.C. § 441b was committed by JWV as it is a registered charitable corporation and a violation of § 441d was committed by JWV as the sticker did not have a disclaimer.

Albert Freiman responded on behalf of the JWV. His response states that the JWV's constitution prohibits the organization to be used for promotion of a political candidate and partisan politics and prohibits the use of its name directly or indirectly for such purposes. The response also denies having a group known as the Ad Hoc Committee; or having authorized, approved, or ratified any actions of such a group. In response to the complainant's allegation that JWV participated in passing out a leaflet, Freiman responded by denying that the JWV in any form or manner authorized, approved or promoted such activity.

Freiman's response indicates that JWV as an organization did not authorize any activity regarding the distribution of the Ad Hoc Committee's letter. From this information, it appears that if any individuals associated with the JWV passed out the letter they were acting on their own volition and not as part of a JWV activity. Therefore, it is recommended that the Commission find no reason to believe JWV violated 2 U.S.C. § 441b.

With regard to the disclaimer allegation, JWV's response denies that it produced the sticker. However, regardless of the responsible party, 11 C.F.R. § 110.11(a)(2) specifically excludes from the requirements of 2 U.S.C. § 441d "bumper stickers, pins, buttons, pens and other similar small items upon which the disclaimer cannot be conveniently printed." The sticker submitted by the complainant is similar to the items mentioned above and thus falls into this exclusion. Therefore, it is recommended that the Commission find no reason to believe a violation of 2 U.S.C. § 441d was committed by JWV.

Rabbi Lubinsky and Agudath Israel of America, Inc.

("Agudath Israel")

The complainant alleges that Agudath Israel produced 100,000 leaflets advocating the electoral defeat of Mel Klenetsky. These leaflets are reportedly reproductions of an article which appeared in the "Jewish Press." No copies of the leaflets were submitted with the complaint. The complainant identifies Rabbi Lubinsky, Director of Government and Public Affairs for Agudath

Israel, as the individual responsible for the leaflet production. The complaint also questions whether Agudath Israel and Rabbi Lubinsky are connected to the Ad Hoc Committee.

In response to the complaint, Rabbi Lubinsky and Boruch Borchardt, Secretary of Agudath Israel, filed affidavits. Both affidavits deny authorizing, publishing, or having any connection with leaflets advocating the defeat of Klenetsky. Additionally, both affidavits contain denials of any association between Agudath Israel and the Ad Hoc Committee.

The complainant appears to be alleging that Agudath Israel by purportedly publishing leaflets advocating the defeat of Klenetsky has made a corporate contribution or expenditure in violation of 2 U.S.C. § 441b. As the allegation concerning the leaflet is vague and the Bouchardt and Lubinsky affidavits categorically deny such activity, it is recommended that the Commission find no reason to believe that Agudath Israel of America, Inc. violated 2 U.S.C. § 441b.

The Generation After

The complainant appears to be alleging that The Generation After, Inc. ("TGA, Inc."), a non-profit corporation, has made a corporate contribution or expenditure in violation of 2 U.S.C. § 441b. The complaint also charges that the Ad Hoc Committee and TGA, Inc. are connected since they share the same post office box.

The complainant bases her allegations on the Ad Hoc Committee's letter which listed its address as Box 364, Baychester Station, New York, New York 10469. This address is the same as the address given by The Generation After on its literature. As noted in the Ad Hoc Committee's section of this report, the letters notifying the Ad Hoc Committee and TGA, Inc. of the filing of the complaint were sent to the same address.

John Ranz responded on behalf of The Generation After, Inc. As John Ranz stated, both letters were received by TGA, Inc. Mr. Ranz refused the Ad Hoc Committee letter as TGA, Inc. is neither the Ad Hoc Committee nor knows of such an organization. Mr. Ranz also denies any knowledge of the author of the Ad Hoc Committee's letter or the sticker submitted with the complaint. He also denies that TGA, Inc. participated in the election process since TGA, Inc. did not publish anything in connection with the New York Primary election.

Based on Mr. Ranz's response it is recommended that the Commission find no reason to believe that TGA, Inc. violated 2 U.S.C. § 441b.

RECOMMENDATIONS

It is recommended that the Commission:

1. Send the attached letter to the complainant, Michele Steinberg, in an attempt to get an address for the Ad Hoc Committee Against Nazism and Anti-Semitism.
2. Find no reason to believe the Jewish War Veterans, Inc. violated 2 U.S.C. § 441d and § 441b.



This is a complaint of what I believe to be violations of the Federal Election Campaign Act (2 U.S.C. 431 et seq.) and related federal regulations, over which the Commission has jurisdiction.

The respondents in this matter are a purported "The Ad Hoc Committee Against Nazism and Anti-Semitism," which upon information and belief includes a group calling itself "the Jewish War Veterans" led by one Manny Goldstein, The Generation After (a.k.a. TGA Inc.), and others at this time unknown. I believe the respondents have violated various sections of the Act, including (but not limited to) Sections 433 ("Registration of Political Committees"), 435(b) ("Campaign advertising requirements"), and 441b ("Contributions or expenditures by national banks, corporations, or labor organizations").

The facts of these violations are as follows:

- 1) On or about September 15 or 16, 1982, a copy of a leaflet titled "WHO IS MEL KLENETSKY?" was obtained in lower Manhattan. The leaflet, attached hereto as Exhibit A, correctly links Mr. Klenetsky to Lyndon H. LaRouche, Jr., and then falsely characterizes Mr. LaRouche as an anti-Semite. The text concludes with the question, "DO YOU STILL WANT TO VOTE FOR MEL KLENETSKY?" The purported authors of the leaflet, "The Ad Hoc Committee Against Nazism and Anti-Semitism," give their address as "Post Office Box 364, Baychester Station, New York, N.Y. 10469," but do not include the notice required in 2 U.S.C. 435(b).
 - 2) On Sunday, September 19, two older men were observed distributing the same leaflet at Broadway and 72nd Street in Manhattan. The two men said they were getting the leaflet out "all over the city" and would be at the polls on election day. They identified themselves as being from "the Jewish War Veterans." Upon information and belief, the Jewish War Veterans are registered as a charitable corporation.
 - 3) We have received information indicating that stickers and other campaign materials, including a sticker with the slogan "A VOTE FOR A NAZI IS A VOTE FOR KLENETSKY," with no information as to sponsorship (i.e. name of a committee) and without the notice required in 2 U.S.C. 435(b) are being printed at Apple Press, Inc. on Mercer Street, New York, NY. We have confirmed

that this printer "does printing for" the Jewish War Veterans. A copy of the "A VOTE FOR . . ." sticker is attached hereto as Exhibit B.

4) The post office box address listed for "The Ad Hoc Committee Against Nazism and Anti-Semitism" is the same listed on the literature of The Generation After, a.k.a. TGA, Inc. Copies of two such "The Generation After" pieces of literature are attached hereto as Exhibits C and D. Exhibit D identifies itself as the "Newsletter of The Generation After, Inc. Even when a non-Jew such as Churchill is added, one is told that he is in thrall to the Rothschilds. In the NCLC publication The Noble Family, the "British" are different than us because they are not human. They are the product of a specialized process of genetic engineering...let us joyfully ensure that the representatives of the British system are destroyed so that humanity might live.

The NCLC has its anti-Semitism fitted carefully to each of its target audiences:

- Blacks are told to hate Jews because Jews control the drug traffic.
- Police are told to hate Jews because Jews are radicals and terrorists.
- Military officers are told to hate Jews because Jews spawn "traitors" like anti-war activist Daniel Ellsberg.

Unlike Hitler, LaRouche is making serious inroads into the wage-earning

stratum of society. In Weimar Germany, most employees were unionized strongly influenced by egalitarian ideologies, rendering them generally immune to Nazi propaganda. In America, no such "protective" ideology exists. LaRouche knows full well. 3. We do not have any "The Ad-Hoc Committee Against Naziism and Anti-Semitism" nor have we authorized, approved or ratified any actions of such group.

4- Since this complaint alleges that upon information and belief a group calling itself "The Jewish War Veterans" has participated in certain actions, we categorically state and deny that the Department of New York, Jewish War Veterans of the United States of America has in any way, form or manner authorized, approved, or promoted such activity.

5- We further express displeasure and disbelief that our Department would be held accountable for any individual or personal actions of any veteran, Jewish or non-Jewish, whether a member of our organization or not, for the commission/omission of certain alleged activities not in any way authorized by us.

Gentlemen:

This is a complaint of what I believe to be violations of the Federal Election Campaign Act (2 U.S.C. 431 et seq.) and related federal regulations, over which the Commission has jurisdiction.

The respondents in this matter are a purported "The Ad Hoc Committee Against Nazism and Anti-Semitism," which upon information and belief includes a group calling itself "the Jewish War Veterans" led by one Manny Goldstein, The Generation After (a.k.a. TGA Inc.), and others at this time unknown. I believe the respondents have violated various sections of the Act, including (but not limited to) Sections 433 ("Registration of Political Committees"), 435(b) ("Campaign advertising requirements"), and 441b ("Contributions or expenditures by national banks, corporations, or labor organizations").

The facts of these violations are as follows:

- 1) On or about September 15 or 16, 1982, a copy of a leaflet titled "WHO IS MEL KLENETSKY?" was obtained in lower Manhattan. The leaflet, attached hereto as Exhibit A, correctly links Mr. Klenetsky to Lyndon H. LaRouche, Jr., and then falsely characterizes Mr. LaRouche as an anti-Semite. The text concludes with the question, "DO YOU STILL WANT TO VOTE FOR MEL KLENETSKY?" The purported authors of the leaflet, "The Ad Hoc Committee Against Nazism and Anti-Semitism," give their address as "Post Office Box 364, Baychester Station, New York, N.Y. 10469," but do not include the notice required in 2 U.S.C. 435(b).
- 2) On Sunday, September 19, two older men were observed distributing the same leaflet at Broadway and 72nd Street in Manhattan. The two men said they were getting the leaflet out "all over the city" and would be at the polls on election day. They identified themselves as being from "the Jewish War Veterans." Upon information and belief, the Jewish War Veterans are registered as a charitable corporation.

that this printer "does printing for" the Jewish War Veterans. A copy of the "A VOTE FOR . . ." sticker is attached hereto as Exhibit B.

4) The post office box address listed for "The Ad Hoc Committee Against Nazism and Anti-Semitism" is the same listed on the literature of The Generation After, a.k.a. TGA, Inc. Copies of two such "The Generation After" pieces of literature are attached hereto as Exhibits C and D. Exhibit D identifies itself as the "Newsletter of The Generation After, Inc. U.S.A." and as published by "TGA, Inc., a non-profit organization," and states that "Contributions to The Generation After are tax deductible." Upon information and belief, only corporations defined in 26 U.S.C. 501(c)(3) are tax deductible.

5) It has been further reported to us that through an organization calling itself "Agudath Israel of America," there are 100,000 leaflets being produced advocating the electoral defeat of Klenetsky. These are reportedly reproductions of an article which appeared in the "Jewish Press." The person who, upon information and belief, is responsible for the production of these leaflets is Rabbi Menachem Lubinsky, Director of Government and Public Affairs of Agudath Israel of America. It has not yet been determined whether either Agudath Israel of America or Rabbi Lubinsky is a part of "The Ad Hoc Committee Against Nazism and Anti-Semitism."

6) Upon information and belief, none of the above-cited individuals and organizations, viz. "The Ad Hoc Committee Against Nazism and Anti-Semitism," "the Jewish War Veterans," Manny Goldstein, The Generation After a.k.a. TGA, Inc., Agudath Israel of America, or Rabbi Lubinsky, have registered with the Commission as political committees, despite their attempts to influence the outcome of the New York Democratic U.S. Senatorial Primary on September 23.

FASCISM IN AMERICA: A TURNING POINT?

"The National Caucus of Labor Committees, a nationwide neo-Nazi organization, has emerged over the past two years to provide homegrown Nazism with resources and political skills unseen since the heyday of the German-American Bund in the late 1930's... they have built up cells in 33 cities, an election machine in more than a dozen states, a budget estimated at well over \$2 million per year, and a vigorous party press..."

As America turns into a new decade, progressive Jews like everyone else must review the past ten years and examine the prospects for the Jewish community in the 1980s. During the 1970s, a most important domestic concern of American Jews was the growth and increasing visibility of the neo-Nazi and Ku Klux Klan movements. According to a recent Anti-Defamation League study, these movements are showing "new signs of life" and have achieved notoriety and publicity disproportionate to their small numbers. Nevertheless, these groups are minor and can never amount to a significant factor in American society. That situation is now completely different. A single, determined, non-Jewish journalist, Dennis King, has written a stunning expose over the last several months of what is in fact quite possible *the greatest threat to the physical existence of the American Jewish community in its history.*

Writing in the New York City community newspaper Our Town, King has uncovered the neo-Nazi organization called the National Caucus of Labor Committees (NCLC). Realizing that public disgust over the Holocaust is a factor preventing neo-Nazism from emerging as a major force in U.S. politics, the NCLC has carefully avoided swastikas and uniforms, disguising their anti-Semitism in code language. The NCLC, on behalf of their leader, Lyndon Hermyie LaRouche, has built up a party apparatus as large as all the other neo-Nazi and KKK groups combined. With an activist cadre of over 1000, the NCLC possesses a highly disciplined command and membership far more educated and more highly motivated than the fringe fascist groups. LaRouche's incredible successes suggests how little the Jewish community really knows about its "goldenah medinah" and its Holocaust potential.

Anti-Semitism and open neo-Nazi propaganda can be found in NCLC literature. In his newspaper New Solidarity, LaRouche dismissed the Holocaust as a "delusion of the American Zionist." The Holocaust curriculum in New York City was attacked as "subversive propaganda with the purpose of undermining the U.S...." Reaching back before the Holocaust, the "kernels of the Protocols of Zion" are declared "factual". LaRouche has gotten around the problem of how to advance his causes in public without attracting a flurry of loud opposition. More often than not, a series of code words and symbols - "British" for Jew, "Republicanism" for fascism, etc. - is being used to catch off-guard observers who may dismiss the NCLC as kooks, while being understandable to that audience on the Right that LaRouche wishes to reach. In NCLC ideology, history has been the struggle between two elites: the humanist republicans who champion reason and productivity; and the usurers who wish to fatten off society. Both elites wage wars via conspiratorial manipulation of the general public. Today, the republicans are NCLC, and the usurers are the "British". With this ideology, LaRouche can evoke a chiliastic fervor in his cadre who believe that the survival of the human race against the "British" depends on their heroic efforts. However, the "British" have suspiciously Judaic names such as Lazard, Meyer, Warburg, Oppenheimer, and of course, Rothschild. Even when a non-Jew such as Churchill is added, one is told that he is in thrall to the Rothschilds. In the NCLC publication *The Noble Family*, the "British"..... are different than us because they are not human. They are the product of a specialized process of genetic engineering....let us joyfully ensure that the representatives of the British system are destroyed so that humanity might live....."

The NCLC has its anti-Semitism fitted carefully to each of its target audiences:

- Blacks are told to hate Jews because Jews control the drug traffic.
- Police are told to hate Jews because Jews are radicals and terrorists.
- Military officers are told to hate Jews because Jews spawn "traitors" like anti-war activist Daniel Ellsberg.

Unlike Hitler, LaRouche is making serious inroads into the wage-earning

stratum of society. In Weimar Germany, most employees were unionized and strongly influenced by egalitarian ideologies, rendering them generally impervious to Nazi propaganda. In America, no such "protective" ideology exists, as LaRouche knows full well. LaRouche has cultivated contacts with the Teamster Union, particularly its gangster elements, spreading its propaganda about how the "British" killed Teamster President Jimmy Hoffa.

The most hair-raising aspect of NCLC is its use of cult-like brainwashing techniques to win over hundreds of young Jews. These Jews run for political office as candidates for the U.S. Labor Party, NCLC's political arm. LaRouche points to their Jewish names to deny his anti-Semitism. To his Jewish followers, LaRouche offers immunity from the coming Holocaust if they renounce their Jewishness and are willing to betray their former Jewish brethren. Like the Nazi offer to the *Judenrat*, LaRouche is asking these Jews to dig their own grave - they will not outlive the termination of their usefulness to LaRouche.

What is LaRouche's grand strategy for attaining power? According to Dennis King, LaRouche hopes to unite industrialists, managerial technocrats, corrupt union officials, law enforcement officials, military officers, and Liberty Lobby types around their mutual hatred of and/or indifference to the scapegoat Jew. This is similar to Hitler's strategy of coalescing the industrialists, the disenfranchised middle class, and disillusioned World War I veterans.

LaRouche has the know-how, the manpower, and more and more money to realize his "grand coalition". LaRouche has established himself as the head of Computron Technologies Corporation, a multi-million dollar computer software corporation whose clients include AT & T, Mobil Oil, and Bristol-Meyers. The resulting income is used by LaRouche's U.S. Labor Party to finance his 1980 presidential election campaign. While he has no hope to win the presidency, he does hope to emerge as a major figure on the Ultra-Right in the United States. Given the following, he may well succeed:

- He made the ballot as a Democrat in New Hampshire and Connecticut, having as many campaign workers as any of the other candidates competing in the primaries.
- He received 2% of the vote in New Hampshire. **CALIF: 78,000**
- He received 3% of the Connecticut vote, beating out California Governor Jerry Brown for third place.

He has achieved what no other extremist candidate in U.S. electoral history has ever done - he has received \$327,864.01 of taxpayers' dollars in the form of federal matching funds for his campaign even though he is at least one year delinquent in filing his financial disclosure statement. *The Federal Election Commission knew this full well and yet gave LaRouche the funds behind closed doors!*

- He purchased half-hour national TV commercial time on ABC (January 20) and on NBC (January 27).

Due to the loss of Third World markets, American power abroad has declined rapidly. Inflation, high unemployment, and recession plague the economy - all at once. As U.S. economic clout declines, significant portions of U.S. industry may become attracted to LaRouche's well-researched fascist economic platform, an attraction that would bring the "grand coalition" perilously close to reality.

Can "it" happen here? Of course! Those who boast about the U.S. "tradition" of democracy are the first to forget that America was built upon the corpses of native American Indians and the sweat of black slaves. In the 1950s, the U.S. introduced "Project Paperclip", whereby hundreds of Nazi war criminals and scientists were allowed into the country to work for the government. LaRouche's activities can not be dismissed as those of a cult or freak show: Hitler began his rise to power with even fewer followers - and no computers. That the "unthinkable" can happen here is all the more likely when nearly all established Jewish organizations virtually ignore LaRouche. If the Establishment is not going to learn from the past, then it is up to progressive, concerned Jews to unite with progressive, concerned non-Jews to hasten the downfall of the NCLC and of Lyndon LaRouche.

If LaRouche goes unopposed, then "1984" will be far more than a book - it will be only four years away.

Both briefs will then be filed with the Commission Secretary and will be considered by the Commission. Thereafter, if the Commission determines by an affirmative vote of four (4) Commissioners, that there is probable cause to believe that a violation of the FECA has been committed or is about to be committed conciliation must be undertaken for a period of at least 30 days but not more than 90 days. If the Commission is unable to correct or prevent any violation of the FECA through conciliation the Office of General Counsel may recommend that the Commission file a civil suit against the respondent(s) to enforce the Federal Election Campaign Act (FECA). Thereafter, the Commission may, upon an affirmative vote of four (4) Commissioners, institute civil action for relief in the District Court of the United States.



DESCRIPTION OF PRELIMINARY PROCEDURES
FOR PROCESSING COMPLAINTS FILED WITH THE
FEDERAL ELECTION COMMISSION

Complaints filed with the Federal Election Commission shall be referred to the Enforcement Division of the Office of General Counsel, where they are assigned a MUR (Matter Under Review) number and assigned to a staff member. Within 5 days of receipt of a complaint, the Commission shall notify, in writing, the respondent listed in the complaint that the complaint has been filed and shall include with such notification a copy of the complaint. Simultaneously, the complainant shall be notified that the complaint has been received and will be acted upon. The respondent(s) shall then have 15 days to demonstrate, in writing, that no action should be taken against him/her in response to the complaint.

At the end of the 15 days, the Office of General Counsel shall report to the Commission making a recommendation(s) based upon a preliminary legal and factual analysis of the complaint and any submission made by the respondent(s). A copy of respondent's submission shall be attached to the Office of General Counsel's report and forwarded to the Commission. This initial report shall recommend either: (a). that the Commission find reason to believe that the complaint sets forth a possible violation of the Federal Election Campaign Act (FECA) and that the Commission will conduct an investigation of the matter; or (b). that the Commission finds no reason to believe that the complaint sets forth a possible violation of the Federal Election Campaign Act (FECA) and, accordingly, that the Commission close the file on the matter.

If, by any affirmative vote of four (4) Commissioners, the Commission decides that it has reason to believe that a person has committed or is about to commit a violation of the Federal Election Campaign Act (FECA), the Office of General Counsel shall open an investigation into the matter. During the investigation, the Commission shall have the power to subpoena documents, to subpoena individuals to appear for deposition, and to order answers to interrogatives. The respondent(s) may be contacted more than once by the Commission during its investigation.

Gentlemen:

This is a complaint of what I believe to be violations of the Federal Election Campaign Act (2 U.S.C. 431 et seq.) and related federal regulations, over which the Commission has jurisdiction.

The respondents in this matter are a purported "The Ad Hoc Committee Against Nazism and Anti-Semitism," which upon information and belief includes a group calling itself "the Jewish War Veterans" led by one Manny Goldstein, The Generation After (a.k.a. TGA Inc.), and others at this time unknown. I believe the respondents have violated various sections of the Act, including (but not limited to) Sections 433 ("Registration of Political Committees"), 435(b) ("Campaign advertising requirements"), and 441b ("Contributions or expenditures by national banks, corporations, or labor organizations").

The facts of these violations are as follows:

1) On or about September 15 or 16, 1982, a copy of a leaflet titled "WHO IS MEL KLENETSKY?" was obtained in lower Manhattan. The leaflet, attached hereto as Exhibit A, correctly links Mr. Klenetsky to Lyndon H. LaRouche, Jr., and then falsely characterizes Mr. LaRouche as an anti-Semite. The text concludes with the question, "DO YOU STILL WANT TO VOTE FOR MEL KLENETSKY?" The purported authors of the leaflet, "The Ad Hoc Committee Against Nazism and Anti-Semitism," give their address as "Post Office Box 364, Baychester Station, New York, N.Y. 10469," but do not include the notice required in 2 U.S.C. 435(b).

2) On Sunday, September 19, two older men were observed distributing the same leaflet at Broadway and 72nd Street in Manhattan. The two men said they were getting the leaflet out "all over the city" and would be at the polls on election day. They identified themselves as being from "the Jewish War Veterans." Upon information and belief, the Jewish War Veterans are registered as a charitable corporation.

3) We have received information indicating that stickers and other campaign materials, including a sticker with the slogan "A VOTE FOR A NAZI IS A VOTE FOR KLENETSKY," with no information as to sponsorship (i.e. name of a committee) and without the notice required in 2 U.S.C. 435(b) are being printed at Apple Press, Inc. on Mercer Street, New York, NY. We have confirmed

that this printer "does printing for" the Jewish War Veterans. A copy of the "A VOTE FOR . . ." sticker is attached hereto as Exhibit B.

4) The post office box address listed for "The Ad Hoc Committee Against Nazism and Anti-Semitism" is the same listed on the literature of The Generation After, a.k.a. TGA, Inc. Copies of two such "The Generation After" pieces of literature are attached hereto as Exhibits C and D. Exhibit D identifies itself as the "Newsletter of The Generation After, Inc. U.S.A." and as published by "TGA, Inc., a non-profit organization," and states that "Contributions to The Generation After are tax deductible." Upon information and belief, only corporations defined in 26 U.S.C. 501(c)(3) are tax deductible.

5) It has been further reported to us that through an organization calling itself "Agudath Israel of America," there are 100,000 leaflets being produced advocating the electoral defeat of Klenetsky. These are reportedly reproductions of an article which appeared in the "Jewish Press." The person who, upon information and belief, is responsible for the production of these leaflets is Rabbi Menachem Lubinsky, Director of Government and Public Affairs of Agudath Israel of America. It has not yet been determined whether either Agudath Israel of America or Rabbi Lubinsky is a part of "The Ad Hoc Committee Against Nazism and Anti-Semitism."

6) Upon information and belief, none of the above-cited individuals and organizations, viz. "The Ad Hoc Committee Against Nazism and Anti-Semitism," "the Jewish War Veterans," Manny Goldstein, The Generation After a.k.a. TGA, Inc., Agudath Israel of America, or Rabbi Lubinsky, have registered with the Commission as political committees, despite their attempts to influence the outcome of the New York Democratic U.S. Senatorial Primary on September 23.

FASCISM IN AMERICA: A TURNING POINT?

"The National Caucus of Labor Committees, a nationwide neo-Nazi organization, has emerged over the past two years to provide homegrown Nazism with resources and political skills unseen since the heyday of the German-American Bund in the late 1930's... they have built up cells in 33 cities, an election machine in more than a dozen states, a budget estimated at well over \$2 million per year, and a vigorous party press..."

Dennis King, Our Town

As America turns into a new decade, progressive Jews like everyone else must review the past ten years and examine the prospects for the Jewish community in the 1980s. During the 1970s, a most important domestic concern of American Jews was the growth and increasing visibility of the neo-Nazi and Ku Klux Klan movements. According to a recent Anti-Defamation League study, these movements are showing "new signs of life" and have achieved notoriety and publicity disproportionate to their small numbers. Nevertheless, these groups are minor and can never amount to a significant factor in American society. That situation is now completely different. A single, determined, non-Jewish journalist, Dennis King, has written a stunning expose over the last several months of what is in fact quite possible *the greatest threat to the physical existence of the American Jewish community in its history.*

Writing in the New York City community newspaper *Our Town*, King has uncovered the neo-Nazi organization called the National Caucus of Labor Committees (NCLC). Realizing that public disgust over the Holocaust is a factor preventing neo-Nazism from emerging as a major force in U.S. politics, the NCLC has carefully avoided swastikas and uniforms, disguising their anti-Semitism in code language. The NCLC, on behalf of their leader, Lyndon Hermyle LaRouche, has built up a party apparatus as large as all the other neo-Nazi and KKK groups combined. With an activist cadre of over 1000, the NCLC possesses a highly disciplined command and membership far more educated and more highly motivated than the fringe fascist groups. LaRouche's incredible successes suggests how little the Jewish community really knows about its "goldenah medinah" and its Holocaust potential.

Anti-Semitism and open neo-Nazi propaganda can be found in NCLC literature. In his newspaper *New Solidarity*, LaRouche dismissed the Holocaust as a "delusion of the American Zionist." The Holocaust curriculum in New York City was attacked as "subversive propaganda with the purpose of undermining the U.S." Reaching back before the Holocaust, the "kernels of the Protocols of Zion" are declared "factual". LaRouche has gotten around the problem of how to advance his causes *in public* without attracting a flurry of loud opposition. More often than not, a series of code words and symbols - "British" for Jew, "Republicanism" for fascism, etc. - is being used to catch off-guard observers who may dismiss the NCLC as kooks, while being understandable to that audience or the Right that LaRouche wishes to reach. In NCLC ideology, history has been the struggle between two elites: the humanist republicans who champion reason and productivity; and the usurers who wish to fatten off society. Both elites wage wars via conspiratorial manipulation of the general public. Today, the republicans are NCLC, and the usurers are the "British". With this ideology, LaRouche can evoke a chiliastic fervor in his cadre who believe that the survival of the human race against the "British" depends on their heroic efforts. However, the "British" have suspiciously Judaic names such as Lazard, Meyer, Warburg, Oppenheimer, and of course, Rothschild. Even when a non-Jew such as Churchill is added, one is told that he is in thrall to the Rothschilds. In the NCLC publication *The Noble Family*, the "British" "...are different than us because they are not human. They are the product of a specialized process of genetic engineering.... let us joyfully ensure that the representatives of the British system are destroyed so that humanity might live...."

The NCLC has its anti-Semitism fitted carefully to each of its target audiences:

- Blacks are told to hate Jews because Jews control the drug traffic.
- Police are told to hate Jews because Jews are radicals and terrorists.
- Military officers are told to hate Jews because Jews spawn "traitors" like anti-war activist Daniel Ellsberg.

Unlike Hitler, LaRouche is making serious inroads into the wage-earning

stratum of society. In Weimar Germany, most employees were unionized and strongly influenced by egalitarian ideologies, rendering them generally impervious to Nazi propaganda. In America, no such "protective" ideology exists, as LaRouche knows full well. LaRouche has cultivated contacts with the Teamster Union, particularly its gangster elements, spreading its propaganda about how the "British" killed Teamster President Jimmy Hoffa.

The most hair-raising aspect of NCLC is its use of cult-like brainwashing techniques to *win over hundreds of young Jews*. These Jews run for political office as candidates for the U.S. Labor Party, NCLC's political arm. LaRouche points to their Jewish names to deny his anti-Semitism. To his Jewish followers, LaRouche offers immunity from the coming Holocaust if they renounce their Jewishness and are willing to betray their former Jewish brethren. Like the Nazi offer to the *Judenrat*, LaRouche is asking these Jews to dig their own grave - they will not outlive the termination of their usefulness to LaRouche.

What is LaRouche's grand strategy for attaining power? According to Dennis King, LaRouche hopes to unite industrialists, managerial technocrats, corrupt union officials, law enforcement officials, military officers, and Liberty Lobby types around their mutual hatred of and/or indifference to the scapegoat Jew. This is similar to Hitler's strategy of coalescing the industrialists, the disenfranchised middle class, and disillusioned World War I veterans.

LaRouche has the know-how, the manpower, and more and more money to realize his "grand coalition". LaRouche has established himself as the head of Computron Technologies Corporation, a multi-million dollar computer software corporation whose clients include AT & T, Mobil Oil, and Bristol-Meyers. The resulting income is used by LaRouche's U.S. Labor Party to finance his 1980 presidential election campaign. While he has no hope to win the presidency, he does hope to emerge as a major figure on the Ultra-Right in the United States. Given the following, he may well succeed:

- He made the ballot as a Democrat in New Hampshire and Connecticut, having as many campaign workers as any of the other candidates competing in the primaries.
- He received 2% of the vote in New Hampshire. **CALIF: 78,000**
- He received 3% of the Connecticut vote, *beating out California Governor Jerry Brown for third place.*

He has achieved what no other extremist candidate in U.S. electoral history has ever done - he has received \$327,864.01 of taxpayers' dollars in the form of federal matching funds for his campaign even though he is at least one year delinquent in filing his financial disclosure statement. *The Federal Election Commission knew this full well and yet gave LaRouche the funds behind closed doors!*

- He purchased half-hour national TV commercial time on ABC (January 20) and on NBC (January 27).

Due to the loss of Third World markets, American power abroad has declined rapidly. Inflation, high unemployment, and recession plague the economy - all at once. As U.S. economic clout declines, significant portions of U.S. industry may become attracted to LaRouche's well-researched fascist economic platform, an attraction that would bring the "grand coalition" perilously close to reality.

Can "it" happen here? Of course! Those who boast about the U.S. "tradition" of democracy are the first to forget that America was built upon the corpses of native American Indians and the sweat of black slaves. In the 1950s, the U.S. introduced "Project Paperclip", whereby hundreds of Nazi war criminals and scientists were allowed into the country to work for the government. LaRouche's activities can not be dismissed as those of a cult or freak show: Hitler began his rise to power with even fewer followers - and no computers. That the "unthinkable" can happen here is all the more likely when nearly all established Jewish organizations virtually ignore LaRouche. If the Establishment is not going to learn from the past, then it is up to progressive, concerned Jews to unite with progressive, concerned non-Jews to hasten the downfall of the NCLC and of Lyndon LaRouche.

If LaRouche goes unopposed, then "1984" will be far more than a book - it will be only four years away.
