On October 5, 1984, the Commission accepted the conciliation agreement signed by you on behalf of the Kansas Democratic State Committee and Larry Gates, as treasurer, in settlement of a violation of 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv), provisions of the Federal Election Campaign Act of 1971, as amended. Accordingly, the file has been closed in this matter, and it will become a part of the public record within thirty days. However, 2 U.S.C. § 437g(a)(4)(B) prohibits any information derived in connection with any conciliation attempt from becoming public without the written consent of the respondent and the Commission. Should you wish any such information to become part of the public record, please advise us in writing.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission (hereinafter "the Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that the Kansas Democratic State Committee and Larry Gates, as treasurer, ("Respondents") violated 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding a probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents, and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Respondent Kansas Democratic State Committee is a political committee registered with the Commission.

2. Larry Gates is the treasurer of the Kansas Democratic State Committee.

3. The Kansas Democratic State Committee was required to file the 1982 Post-General Election Report by December 2, 1982. The report was filed on June 13, 1984.

4. The Kansas Democratic State Committee was required to file the 1982 Year-End Report by January 31, 1983. The report was filed on June 13, 1984.

5. The Kansas Democratic State Committee was required to file the 1983 Year-End Report by January 31, 1984. The report was filed on June 21, 1984.

6. The Kansas Democratic State Committee was required to file the 1984 April Quarterly Report by April 15, 1984. The report was filed on June 21, 1984.

V. Respondents violated 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv) by failing to file timely the 1982 Post-General Election Report, the 1982 Year-End Report, the 1983 Year-End Report, and the 1984 April Quarterly Report.

VI. Respondents will pay a civil penalty to the Treasurer of the United States in the amount of Two Hundred Dollars (\$200), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. Respondents agree that they shall not undertake any activity which is in violation of the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. § 431, et seq.

VIII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a) (1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.


IX. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.


X. Respondents shall have no more than thirty (30) days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.

XI. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be valid.

Enclosed are the 1983 Year End and 1984 April Quarterly Reports. These two reports, along with the two 1982 reports I found here (and sent) on June the 7th after searching for the third time through old files, should complete all items listed in the May 24 "reason to believe" letter from Lee Ann Elliott.

As I mentioned to Lois Lerner on the phone week before last, the fact that those two 1982 reports were here in the State Committee's old filing system makes me think that they must have been filed. As for the two reports filed with this letter, I can only say that I misjudged what I told Mike Fuller's office about how much time it would take to oversee our delegate selection process, to build my new staff, and to reorganize the poor bookkeeping and filing system I inherited here last winter when I started this job. The bookkeeping and filing systems, especially, slowed down getting the necessary information for these two reports.

Although I realize that I have no proof that the two 1982 reports were ever sent by the State Committee's previous staff and that these two enclosed reports are in fact late, I do think that the special circumstances of this Presidential Year and the Kansas Democratic Party's total change of Headquarters staff merits consideration in your review of our case.

Dear Mr. Gates:

On May 23, 1984, the Federal Election Commission determined that there is reason to believe the Kansas Democratic State Committee and you, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(i), (iii) and (iv), provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The General Counsel's factual and legal analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against you and the committee. You may submit any factual or legal materials which you believe are relevant to the Commission's consideration of this matter. Please submit any such materials within ten days of your receipt of this letter.

In the absence of any additional information which demonstrates that no further action should be taken against your committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation. 





In addition, in a general election year a Post-General Election Report is required to be filed no later than the 30th day after the general election, which shall be complete as of the 20th day after such general election. 2 U.S.C. § 434(a)(4)(A)(iii). In any other calendar year, a report covering the period beginning July 1 and ending December 31, is required to be filed no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(iv).

The Committee and its treasurer were required to file the 1982 30 Day Post-General Election Report, the 1982 Year-End

Report, the 1983 Year-End Report, and the 1984 April Quarterly Report by December 2, 1982, January 31, 1983, January 31, 1984, and April 15, 1984, respectively. The Committee, however, has yet to file any of these reports, two of which are more than one year late. In view of the Committee's failure to file the 1982 30 Day Post-General Election Report, the 1982 Year-End Report, the 1983 Year-End Report and the 1984 April Quarterly Report, it is the recommendation of the Office of General Counsel that the Commission find reason to believe the Committee and its treasurer violated 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv).
