CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission (hereinafter "the Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that the Democratic Party of New Mexico and Richard Kennedy, as treasurer, (hereinafter "Respondents"), violated 2 U.S.C. § 434(a)(4)(A)(i), (ii) and (iii).

NOW, THEREFORE, the Commission and Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents, and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. The Democratic Party of New Mexico is a political committee registered with the Commission.

2. Richard Kennedy is the treasurer of the Democratic Party of New Mexico.

3. The Respondents were required to file the 1984 Pre-General Report on October 25, 1985. The report was filed on May 20, 1985.

4. The Respondents were required to file the 1984 Post-General Report on December 6, 1985. The report was filed on May 20, 1985.

5. The Respondents were required to file the 1984 Year-End Report on January 31, 1985. The report was filed on May 20, 1985.

V. Respondents violated 2 U.S.C. § 434(a)(4)(A)(i), (ii) and (iii) by failing to file timely the 1984 Pre-General, Post-General and Year End Reports.

VI. Respondents will pay a civil penalty to the Treasurer of the United States in the amount of one thousand dollars (\$1,000) pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. Respondents agree that they shall not undertake any activity that is in violation of the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. § 431, et seq.

VIII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirements thereof has been violated, it may institute a

civil action for relief in the United States District Court for the District of Columbia.


IX. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.


X. Respondents shall have no more than thirty (30) days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.

This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be valid.






Dear Mr. Kennedy:



**GENERATION OF MATTER**

This matter was referred to the Office of General Counsel on April 11, 1985, by the Reports Analysis Division (Attachment 1).

**SUMMARY OF ALLEGATIONS**

It is alleged that the Democratic Party of New Mexico ("DPNM") violated 2 U.S.C. § 434(a)(4)(A)(i), (ii) and (iii) by not timely filing its 1984 Pre-General, Post-General and Year End Reports.

**FACTUAL AND LEGAL ANALYSIS**

Facts

On October 1, 1984, DPNM was sent notification of the requirement that all quarterly filing committees that have made contributions or expenditures in connection with the general election must file a 12-Day Pre-General Election Report by October 25, 1984, if such activity had not been previously reported. DPNM filed its Pre-General Report, showing unreported financial activity, on May 20, 1985, 207 calendar days late.

On October 1, 1984, DPNM was sent notification of the requirement that a Post-General Election Report must be filed by

December 6, 1984. DPNM filed its Post-General Election Report on May 20, 1985, 165 calendar days late.

On December 27, 1984, DPNM was sent a Chronic Late Filer Notice for failing to file the 1984 April, July and October Quarterly Reports and the 1984 Post-General Report in a timely manner.

On January 7, 1985, DPNM was sent notification it was required to file a Year End Report by January 31, 1985. DPNM filed its Year End Report on May 20, 1985, 132 calendar days late.

By letter dated April 4, 1985, (Attachment 2) DPNM requested pre-probable cause conciliation for its 1984 Pre-General and Post-General Election Reports and its 1984 Year End Report, prior to a finding of reason to believe that those reports were filed late.

Legal Analysis

DPNM is a political committee other than the authorized committee of a candidate. As such, DPNM is required to file the necessary reports as prescribed in 2 U.S.C. § 434(a)(4)(A).

Under 2 U.S.C. § 434(a)(4)(A)(ii), an unauthorized committee must file a Pre-General Election Report no later than the 12th day before a general election, in this case October 25, 1984. Under 2 U.S.C. § 434(a)(4)(A)(iii), an unauthorized committee must file a Post-General Election Report no later than 30 days after a general election, in this case December 6, 1984. Under 2 U.S.C. § 434(a)(4)(A)(i), an unauthorized committee must file a

Year-End Report no later than January 31. DPNM filed its 1984 Pre-General, Post-General and Year End Reports on May 20, 1985. Therefore the Office of General Counsel recommends the Commission find reason to believe DPNM violated 2 U.S.C. § 434(a)(4)(A)(i), (ii) and (iii).

## III. BACKGROUND:

## Late and Non-Filing of Reports

The Democratic Party of New Mexico ("the Party") was referred previously for not filing the 1984 April and October Quarterly Reports in a timely manner (see MURs 1767 and 1902, respectively).<sup>\*/</sup> Since that time the Party has not filed the 30 Day Post-General and 1984 Year End Reports (see chart on Page 3).

On December 27, 1984, the Party was sent a Chronic Late Filing Notice for failing to file the 1984 April, July and October Quarterly Reports and the 1984 30 Day Post-General Reports in a timely manner (Attachment 10). Subsequent to that notification, however, the Party has failed to file the 1984 Year End Report.

On December 28, 1984, a Non-Filer Notice was sent for the 1984 30 Day Post-General Report (Attachment 11). A Reports Analysis Division ("RAD") analyst contacted Richard Kennedy, the treasurer of the Party, on January 22, 1985 (Attachment 12). Mr. Kennedy stated that the Party had staffing changes and recently moved. He indicated, however, that a report would be filed promptly. As of this date the report has not been received.



Therefore the Office of General Counsel recommends the Commission find reason to believe DPNM violated 2 U.S.C. § 434(a)(4)(A)(i), (ii) and (iii).
