SUBJECT: QUARTERLY FILERS (UNAUTHORIZED COMMITTEES) WHICH
FAILED TO FILE THE 1986 12 DAY PRE-GENERAL REPORT
BY ELECTION DAY

The attached list of unauthorized committees consists of forty-nine (49) quarterly filers which failed to file a 1986 12 Day Pre-General Report by Election Day, November 4, 1986. In accordance with of the RAD Review and Referral Procedures, further examination is required by your office.

Unlike the mandatory reporting requirement placed upon monthly filers, 2 U.S.C. §434(a)(4)(A)(ii) requires quarterly filers to submit 12 Day Pre-General Reports only if the committees make contributions to or expenditures on behalf of federal candidates involved in the general election. All unauthorized committees were sent prior notification regarding the pre- and post-general filing requirements on September 29, 1986 (Attachment 50).

The Party/Non-Party Branch conducted a thorough examination to identify quarterly filers disclosing contributions or expenditures between October 1 and October 15, 1986. The research revealed committees that submitted:

- a) 12 Day Pre-General Reports in an untimely manner;
- b) 30 Day Post-General Reports indicating that 12 Day Pre-General Reports should have been filed; and
- c) Year End Reports indicating that 12 Day Pre-General Reports should have been filed.

I. GENERATION OF MATTER

The Report Analysis Division ("RAD") referred the above-listed 49 committees to the Office of the General Counsel on May 22, 1987. The basis of the attached referrals is their failure to either file a 12-day Pre-Election Report or file such report in a timely fashion.

II. FACTUAL AND LEGAL ANALYSIS

The Federal Election Campaign Act of 1971, as amended ("the Act"), provides that for unauthorized committees filing quarterly, such committees shall file a Pre-Election Report before any election in which the committee makes a contribution to or expenditure on behalf of a candidate in such election. Such report shall be filed no later than the 12th day before (or posted by registered or certified mail no later than the 15th day before) such election and shall be complete as of the 20th day before the election. 2 U.S.C. § 434(a)(4)(A)(ii).

The 1986 Pre-Election Report for the 1986 General Election was due on October 23, 1986, complete as of October 15, 1986. Quarterly

filers were notified on September 29, 1986, of the requirement for filing the Pre-Election Report.

Dear Mr. Edholm:

On June 15, 1987, the Federal Election Commission found that there is reason to believe Massachusetts Republican State Committee ("Committee") and you, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(ii), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against the Committee and you, as treasurer. You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office, within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath.

In the absence of any additional information demonstrating that no further action should be taken against the Committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

If you are interested in pursuing pre-probable cause conciliation, you should so request in writing. See 11 C.F.R. § 111.18(d). Upon receipt of the request, the Office of the General Counsel will make recommendations to the Commission either proposing an agreement in settlement of the matter or recommending declining that pre-probable cause conciliation be pursued. The Office of the General Counsel may recommend that pre-probable cause conciliation not be entered into at this time so that it may complete its investigation of the matter. Further, the Commission will not entertain requests for pre-

probable cause conciliation after briefs on probable cause have been mailed to the respondent.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel will not ordinarily give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

The investigation now being conducted will be confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

For your information, we have attached a brief description of the Commission's procedures for handling possible violations of the Act. If you have any questions, please contact Jacqueline Jones-Smith, the attorney assigned to this matter, at (202) 376-5690.





October 1 - November 24, 1986.

As you can see by an examination of the two reports, only one check
was issued which was a contribution to a candidate, thereby neces-
sitating a pre-election report. We sincerely hope that this fact
will prompt you to agree that there was no willful neglect in not
filing this report, and we trust that we may now close this file.

On June 15, 1987, the Federal Election Commission found reason to believe Massachusetts Republican State Committee ("Committee") and you, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(ii), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). On June 29, 1987, you were notified of this finding and informed that if you were interested in pursuing pre-probable cause conciliation, you should so request in writing. See 11 C.F.R. § 111.18(d).

On July 15, 1987, the Commission received your response to its June 29, 1987 letter. However, it is not clear from your letter whether you wish to settle this matter prior to a finding of probable cause to believe. Unless we receive a written request from you within five (5) days, this Office will consider your July 15, 1987, letter as your complete response and will proceed to the next stage of the enforcement process.



This letter confirms our recent telephone conversation, during which I informed you that I represent the Massachusetts Republican State Committee and James L. Edholm, as Treasurer, in connection with this matter. I enclose a Statement of Designation of Counsel for your files.

Pursuant to 11 CFR §111.18(d), the State Committee requests pre-probable cause conciliation in connection with this matter. Such conciliation would be, we believe, appropriate for the following reasons:

1. The circumstances resulting in the RTB finding arose by error rather than intentionally or by willful neglect. As Mr. Edholm stated in his letter to you of July 15, 1987, the State Committee failed to file the required 1986 pre-election report covering the period of October 1 through October 15, 1986, and instead mistakenly filed a post-election report covering the period from October 1 through November 24, 1986.
2. The State Committee has corrected, or taken steps to correct, the procedures which resulted in omission of the pre-election report. On August 17, 1987, Ray Shamie directed me, as General Counsel, to prepare a schedule of state and federal reporting requirements. I plan to compile such a schedule, with information supplied by the Commission, for use by the State Committee. Additionally, there have been personnel changes and additions to the State Committee staff responsible for compiling financial reporting data.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("the Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that Massachusetts Republican State Committee and James L. Edholm, as treasurer, ("Respondents") violated 2 U.S.C. § 434(a)(4)(A)(ii).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Respondent, Massachusetts Republican State Committee, is a political committee within the meaning of 2 U.S.C. § 431(4).

2. Respondent, James L. Edholm, is the treasurer of Massachusetts Republican State Committee.

3. Pursuant to 2 U.S.C. § 434(a)(4)(A)(ii), Respondents are required to file a 12-Day Pre-Election Report before any election in which they make a contribution to or expenditure on behalf of a candidate.

4. The 12-Day Pre-Election Report for the 1986 General Election was due on October 23, 1986, and complete as of October 15, 1986.

5. Respondents did not file a 12-Day Pre-Election Report prior to the 1986 General Election

6. Respondents filed a 1986 Post-General Election Report on December 30, 1986, that disclosed a \$250 contribution to one (1) candidate between October 1, 1986, and October 15, 1986. Respondents were required, therefore, to file a 12-Day Pre-Election Report by October 23, 1986.

V. Respondents failed to file the 12 Day Pre-Election Report in violation of 2 U.S.C. § 434(a)(4)(A)(ii).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Seven Hundred Twenty Five Dollars (\$725.00), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this

agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Respondents shall have no more than thirty (30) days from the date this agreement becomes effective to comply with and implement the requirement contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.
