To Whom It May Concern:

We respectfully request that your office conduct an investigation of the following political campaign fundraising scheme to determine if it complies with federal statutes regulating political campaigns and elections.

The Republican Presidential Task Force is mailing out a campaign fund-raising letter that is misleading and could be illegal. Senator Roy C. Afflerbach received a copy of this fundraising letter and constituents of Representative Babette Josephs also received copies. A copy of the fundraising letter and material accompanying it is enclosed.

The three-page letter includes a \$25 check made payable to the solicitee. The letter states that the check is real. However, by endorsing this check and depositing it into a checking account, the person will then be participating in "the Republican Party's newest Candidate Escrow Funding concept."

It is not until 12 paragraphs into the letter that the new "Candidate Escrow Funding concept" is defined. It means that the person depositing the check is giving the Republican Presidential Task Force the authority to automatically withdraw \$12.50 a month from his or her checking account.

The letter explains that involvement in this program can be terminated by calling the organization at a toll-free number. But before a person can terminate his or her involvement, he or she must first complete a two-month test trial period in the program.

In other words, the Republican Presidential Task Force is guaranteed to recoup its \$25 check by deducting \$12.50 a month from a person's checking account for at least the first two months.

Some questions we have about this fund-raising scheme include: Is this a legitimate campaign fundraiser under the United States election law? What political campaigns are supported by money donated to this fund? (The name "Republican Presidential Task Force" provides the impression that fundraising is being conducted for presidential elections when in fact, small print at the bottom of the first page indicates the money is being collected by the National Republican Senatorial Campaign.) Would a person participating in this scheme be subject to campaign finance reporting requirements? Can a person cash this check without obligating himself to further contributions to the Republican Presidential Task Force?

Another concern we have with this fund-raising scheme is that the Task Force is actually making contributions to political campaigns in the names of other people -- i.e. in the names of all the people who cash the check and by cashing the check, return the money to the Task Force as a political contribution. Another interesting question is whether or not the Task Force will report these contributions under its political action committee or as contributions by individuals. If the money is reported as individual contributions, it is then possible that the Task Force will actually be distributing funds in excess of legal limits to political campaigns.

The Federal Election Commission received a complaint which alleges that the National Republican Senatorial Committee and you, as treasurer, may have violated the Federal Election Campaign Act of 1971, as amended ("the Act"). A copy of the complaint is enclosed. We have numbered this matter MUR 3123. Please refer to this number in all future correspondence.

Under the Act, you have the opportunity to demonstrate in writing that no action should be taken against you in this matter. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Where appropriate, statements should be submitted under oath. Your response, which should be addressed to the General Counsel's Office, must be submitted within 15 days of receipt of this letter. If no response is received within 15 days, the Commission may take further action based on the available information.

This matter will remain confidential in accordance with 2 U.S.C. § 437g(a)(4)(B) and 5 437g(a)(12)(A) unless you notify the Commission in writing that you wish the matter to be made public. If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

Dear Mr. Noble:

I am submitting this response on behalf of the National Republican Senatorial Committee ("NRSC") in reply to a complaint filed by Sen. Roy C. Afflerbach and Rep. Babette Josephs and designated Matter Under Review ("MUR") 3123. An executed Designation of Counsel form is enclosed. The complaint does not specifically allege any violations of the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. §§ 431-455 ("Act"), with respect to a direct mail funds solicitation sent by the "Republican Presidential Task Force," a fundraising designation of the NRSC. Furthermore, the Federal Election Commission ("FEC" or "Commission") has already addressed issues pertaining to this activity in MUR 3051, in which the Commission voted to find no reason to

believe the Respondent violated 2 U.S.C. §§ 441a and 441f. For the reasons set forth herein, the FEC should find no reason to believe that the NRSC has violated any provision of the Act.

In their Complaint, two state legislators from Pennsylvania "request that [the FEC Office of the General Counsel] conduct an investigation of the following political campaign fundraising scheme to determine if it complies with federal statutes regulating political campaigns and elections." They offer no examples of alleged statutory violations, solely providing their own abbreviated summary of the NRSC fundraising programs known as "Republican Presidential Task Force" and "Candidate Escrow Funding."

The questions raised by Complainant do not appear to address any new election law issues for the Commission to review. Should the General Counsel's Office disagree with respondent that these issues have already been adjudicated by the Commission in MUR 3051, respondent would greatly appreciate the opportunity to address any issues which the General Counsel's Office believes to be raised for the first time in MUR 3123. Respondent would be grateful for the opportunity to address such matters prior to the recommendation regarding reason to believe by the Office of General Counsel to the Commission in MUR 3123.



I. GENERATION OF MATTER

This matter was generated by a complaint filed on September 18, 1990, by Roy C. Afflerbach, a Pennsylvania State Senator. A response was filed by counsel for the National Republican Senatorial Committee ("NRSC") and James L. Hagen, as treasurer ("the Respondents"), on October 12, 1990.

II. FACTUAL AND LEGAL ANALYSIS

The complaint raises questions concerning the legality of a solicitation by the NRSC under the name of the Republican Presidential Task Force that included a \$25 check the recipient could deposit in his or her account in order to initiate a monthly electronic transfer of \$12.50 from the recipient to the

NRSC.

As we noted in the First General Counsel's Report, dated October 10, 1990, in MUR 3118, this Office has received a number of improper complaints regarding this solicitation. As counsel for the Respondents points out, the issues raised in the complaint have already been addressed in MUR 3051, now MUR 3098.

On October 15, 1990, the Commission approved our recommendation in MUR 3118 to take no action at this time in that matter pending resolution of MUR 3098. We make a similar recommendation here. As noted in our report in MUR 3118, once MUR 3098 is resolved and closed, this Office will prepare a single report relating to all the other pending matters regarding this solicitation.

III. RECOMMENDATIONS

Take no action at this time pending resolution of MUR 3098.

GENERAL COUNSEL'S REPORT

I. BACKGROUND

MUR 3118 was generated with a complaint filed by Morgan P. Kelly on August 27, 1990. A response was filed by counsel for the National Republican Senatorial Committee and James L. Hagen, as treasurer, ("Respondents" or "NRSC") on September 19, 1990.

MUR 3123 was generated with a complaint filed by Roy C. Afflerbach and Babette Josephs on September 18, 1990. A response was filed by counsel for the Respondents on October 9, 1990.

On October 15, 1990, the Commission voted to take no action in MUR 3118 pending the resolution of MUR 3098. On October 23, 1990, the Commission voted to take no action in MUR 3123 pending the resolution of MUR 3098.

II. ANALYSIS

MUR 3118 and MUR 3123 both concern the same solicitation by the National Republican Senatorial Committee. This solicitation was also the issue in MUR 3098. The solicitation was operated by the Republican Presidential Task Force, a fundraising program of the NRSC. The program involved sending \$25 checks payable to the recipient. By endorsing and depositing the check, the recipient

authorized the NRSC to make automatic electronic withdrawals of \$12.50 per month from the recipient's bank account. The NRSC reported the funds it received through this program as contributions.

Because this solicitation was already being investigated in MUR 3098, the General Counsel recommended in its reports on MUR 3118 and MUR 3123 that the Commission take no action in any subsequent matters relating to this solicitation. The Commission voted to take no action in MUR 3118 pending the resolution of MUR 3098 on October 15, 1990; and voted to take no action in MUR 3123 pending the resolution of MUR 3098 on October 23, 1990.

In MUR 3098, the Commission found reason to believe that the Respondents had violated 2 U.S.C. § 434(b) by failing to report the initial \$25 the NRSC received back from each recipient as an offset to operating expenditures. The Commission also found no reason to believe that the Respondents violated 2 U.S.C. § 441a or § 441f. The Respondents, in light of these findings, amended their April and July 1990 Quarterly Reports, and informed the Commission that such amounts would be reported as offsets in the future. On November 28, 1990, the Respondents requested that the Commission take no further action in this matter. The Commission voted on December 18, 1990, to take no further action against the Respondents and close the file in MUR 3098.

In view of the Commission's decisions in MUR 3098, the General Counsel now recommends that the Commission find reason to believe that the Respondents violated 2 U.S.C. § 434(b) and take no further action in MUR 3118 and MUR 3123 and close each of


these files. The Section 434(b) violation is the same in these cases as the one found in MUR 3098. The Respondents have since amended their April and July 1990 Quarterly Reports to reflect the Commission's finding in MUR 3098. The Respondents have also informed the Commission that such amounts will be reported as offsets to operating expenditures in the future. Because the issues in MUR 3118 and MUR 3123 are the same issues which were resolved in MUR 3098, it is now appropriate for the Commission to take similar action in these matters.

III. RECOMMENDATIONS

1. Find reason to believe that the National Republican Senatorial Committee and James L. Hagen, as treasurer, violated 2 U.S.C. § 434(b) in MUR 3118.
2. Take no further action in MUR 3118.
3. Close the file in MUR 3118.
4. Find reason to believe that the National Republican Senatorial Committee and James L. Hagen, as treasurer, violated 2 U.S.C. § 434(b) in MUR 3123.
5. Take no further action in MUR 3123.
6. Close the file in MUR 3123.
7. Approve the appropriate letters.

Hagen, as treasurer, violated 2 U.S.C. § 434(b), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). However, after considering the circumstances of this matter, the Commission also determined to take no further action and closed its file in this matter. 
