



The following is in response to your letter of September 17, 1992 regarding a complaint against The Judy Jarvis for Congress Committee. As the new treasurer for the Committee, I have reviewed the prior reports and activity of the Committee and determined that amended reports are required for the prior periods.

The problems occurred solely in the area of credit card advances. The prior treasurer reported these deposits as advances from the candidate; not understanding the reporting requirements of these types of advances.

Addressing the complaint and the specific items:

- Financial Disclosure Statement

Items 1 and 2 - the financial disclosure statement is not incorrect. It appears so only because of the error in the Campaign Report. The amended reports correct this problem.

- FEC Form 3

Items 1 through 7 - regarding loans. All loans are correctly reported in the enclosed amended reports.

This letter is a request that the Commission take no further action in this matter. The amended reports, which are factual in nature, represent an actual picture of the Committee's financial position.






