





Dear Commissioner Aiken:

The State Democratic Party of Alabama has several concerns involving the above identified report.

1) In a reporting period of only 47 days, there is an amount of unitemized receipts of \$116,400.00. 102.9 (a) (2) requires that contributions aggregating over \$200 must be itemized and contributions exceeding \$50 must be documented in his records 102.9 (a) (1) even though not reportable. Mr. Sellers has refused to make available to the public his list of unitemized receipts. We are concerned that this amount may not represent actual cash on hand. Mr. Sellers has stated publically that he had used a direct mail effort in obtaining these small contributions, but his records of disbursements reflects postage only on May 21,22,23, and June 23. An unnatural short period of time to accumulate contributions of such a substantial amount.

We request that Mr. Sellers offer the Federal Election Commission some documentation of the source of these contributions.


(2) In the same reporting period of only 47 days there is an amount on 11 (d) of \$71,500.00, from the candidate. This amount is listed as completely in-kind from the candidate. We contend that the amounts are excessive and give as an example the following figures: part of this amount for this time period is for computer services of \$30,000, rent of \$20,500 and furniture rental of \$13,500. The rent, alone, would represent a monthly rental of over \$13,000 a month which is not supported by market value in this area.

We request that Mr. Sellers support his 47 days of in-kind contributions with documentation.



The Federal Election Commission received a complaint which indicates that the Sellers for U.S. Senate Committee ("Committee") you, as treasurer, may have violated the Federal Election Campaign Act of 1971, as amended ("the Act"). A copy of the complaint is enclosed. We have numbered this matter MUR 3614. Please refer to this number in all future correspondence.

Under the Act, you have the opportunity to demonstrate in writing that no action should be taken against the Committee or you, as treasurer, in this matter. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Where appropriate, statements should be submitted under oath. Your response, which should be addressed to the General Counsel's Office, must be submitted within 15 days of receipt of this letter. If no response is received within 15 days, the Commission may take further action based on the available information.

This matter will remain confidential in accordance with 2 U.S.C. § 437g(a)(4)(B) and § 437g(a)(12)(A) unless you notify the Commission in writing that you wish the matter to be made public. If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

Dear Ms. Klein:

This letter is in response to Ms. Dawn M. Odrowski's letter of October 21, 1992, enclosing your letter of September 24, 1992 regarding MUR 3614, and asking for a response by November 5, 1992. This request caused us to file late our October reports which are included.

This complaint was obviously very partisan. No questions have been raised by the Alabama Democratic Party Executive Director about incumbent Senator Richard Shelby who made illegal contributions of \$75,000 through a corporation to two PAC's: the Alabama Democratic Conference and the New South Coalition. These were abuses in the Democratic Primary for which the Executive Director should have raised questions.

We don't believe any action should be taken against the Sellers campaign since we did not violate the Federal Election Act of 1971, as amended. However, we have amended our earlier reports to better show actual contributions and in-kind contributions from the candidate. I might point out that even though we did make some accounting mistakes, we went beyond the law in trying to show our contributions. Our only problem is that we disclosed more than the law requires.

In response to the Alabama Democratic Party's question #1, I was under the impression we were suppose to list "pledged contributions" in addition to actual money deposited. We kept a list of people who pledged contributions by phone, by mail, or in person. This was all part of our computer system. We did not need the money until October for TV, so pledges were the mainstay of our campaign during the Spring and Summer.

It turns out this was not a smart move. Polling data came out showing us 51 points behind in September 1992. Therefore, most of the pledges did not come in as promised. We will not make this mistake again. Our amended reports show only the amount of cash deposited, not pledges.


In response to question #2, the in-kind contributions of \$71,500 should have been reported over the ten month period from September 1, 1991 to June 30, 1992. We tried to be very forthcoming and report all in-kind contributions from the candidate. The contribution dates used on the original July 15, 1992, report were an estimate of time the equipment was used in the ten prior months. This equipment time estimate should have been reported on the April 15th and Pre-primary reports, but we did not think about it then.

Richard Sellers, the candidate, does charge his small business clients for letters, video shooting, computer time, list rental, etc. However, since family and volunteers were using this equipment, it was very hard to get an exact estimate of how much this personally owned equipment was being used. We came up with the following formula for monthly charges: computer: \$3,000; mailing list rental: \$2,050; furniture rental: \$1,350; software use: \$500; and video shooting time: \$250.

We have amended our April 15th, Pre-primary, and July 15th reports accordingly. We hope this satisfies any concerns the FEC or the Alabama Democratic Party may have.

Our only problem is that we have attempted to report much more than the law requires. Please let me know at 205/272-6150 if you have any questions.

SELLERS FOR U.S. SENATE COMMITTEE

The State Democratic Party of Alabama filed this complaint alleging that Mr. Sellers and his Committee inaccurately reported unitemized contributions from individuals and in-kind contributions from the candidate. Complainant based its allegation on the relatively high amounts reported for those line items in the Committee's 1992 July Quarterly report. The Committee admits it mistakenly reported "pledges" of contributions instead of actual contributions received in its 1992 July Quarterly report. The Committee also reported in-kind contributions from the candidate in that report which should have been reported over a ten-month period. The Committee filed amended reports reflecting its actual unitemized receipts and receipt of in-kind contributions from the candidate over the preceding nine-month period.

This matter raises no significant issues relative to the other issues pending before the Commission and there is no indication of any serious intent by Respondents to violate the FECA. Moreover, this case had limited impact on the process and the Committee undertook some remedial action.

The confidentiality provisions of 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. In addition, although the complete file must be placed on the public record within 30 days, this could occur at any time following certification of the Commission's vote. SELLERS FOR U.S. SENATE COMMITTEE

The State Democratic Party of Alabama filed this complaint alleging that Mr. Sellers and his Committee inaccurately reported unitemized contributions from individuals and in-kind contributions from the candidate. Complainant based its allegation on the relatively high amounts reported for those line items in the Committee's 1992 July Quarterly report. The Committee admits it mistakenly reported "pledges" of contributions instead of actual contributions received in its 1992 July Quarterly report. The Committee also reported in-kind contributions from the candidate in that report which should have been reported over a ten-month period. The Committee filed amended reports reflecting its actual unitemized receipts and receipt of in-kind contributions from the candidate over the preceding nine-month period.

This matter raises no significant issues relative to the other issues pending before the Commission and there is no indication of any serious intent by Respondents to violate the FECA. Moreover, this case had limited impact on the process and the Committee undertook some remedial action.
