Dear Chairman Aikens,

The purpose of this letter is to lodge two formal complaints against State Representative Peg Lautenschlager, a candidate for Congress from Wisconsin's 6th Congressional District. As chairman of the 6th District's Republican Committee, I urgently request that you investigate both of these complaints, the first involving what appears to be an illegal campaign contribution, and the second involving misleading and deceptive reporting of contributions.

In Rep. Lautenschlager's campaign finance report dated August 24, 1992, Rep. Lautenschlager lists a \$500 payment on August 1 to Garin-Hart Strategic Research Group for a poll. Rep. Lautenschlager apparently passed the poll results around in order to raise funds, and the enclosed memo of May 13 from Garin-Hart to Rep. Lautenschlager demonstrates that she received the results promptly after the survey was taken, which was on May 7 and 8. I can find no other payment for this poll on Rep. Lautenschlager's state or federal reports.

This poll had a survey sample of 402 voters and contained numerous questions. Surveys of this sort cost approximately \$10,000, which is twice the allowable \$5,000 pre-primary campaign contribution limit for a PAC and 10 times the allowable \$1,000 pre-primary campaign contribution limit for individuals. Yet, once again, Rep. Lautenschlager reports paying only \$500 for this poll. I would like to know who paid the rest of the money for the poll. And did this person or organization also make additional illegal contributions directly to Rep. Lautenschlager's campaign?

Rep. Lautenschlager had a second similar poll conducted in September and she reports having paid Garin-Hart \$9,500 for this second survey. The differing price of the first and the second polls is glaring.

In addition, Rep. Lautenschlager has incorrectly listed campaign contributions of \$8,600 from the campaign committees of her State Assembly and State Senate colleagues. Her listing is designed to give the impression that these contributions are from individuals rather than from campaign committees. The intent is to mislead people into thinking that she is receiving a higher percentage of her contributions from individuals as opposed to campaign committees.



Presented deceptively and inaccurately, as of September 30th, Rep. Lautenschlager appears to have received 51 percent of her support from political action committees, and 40 percent from individuals. Presented honestly and accurately, she has in fact received 57 percent from political committees, including PACS, and 35 percent from individuals. I believe Rep. Lautenschlager should be reprimanded for her deceptive tactics.

I urge your prompt attention to these matters.

Our survey of 402 likely voters in Wisconsin's 6th congressional district shows that Congressman Tom Petri brings substantial vulnerabilities to his reelection bid and that you are well positioned to unseat him. Mr. Petri's political standing among 6th C.D. voters is lackluster and presents him with serious obstacles during a period in which the electorate has a strong desire for change in Washington.

Perhaps the most striking demonstration of Congressman Petri's electoral weakness is the result of the trial heat. While most challengers typically begin their campaign at a substantial deficit to the incumbent, a Petri-Lautenschlager congressional race would be very competitive right at the start, as the following table shows:

This is obviously an unimpressive showing for an incumbent, and Petri's vulnerability is even more apparent when we find that only 46% of his voters are firmly committed in their support.

Your showing in the trial heat against Congressman Petri is even more remarkable considering that he holds a substantial 48-point edge over you in name recognition in the district. In fact, among voters who are familiar with both candidates, you lead the Congressman by 12 points (53% to 41%).

In addition to the very encouraging result of the trial heat, several other survey findings demonstrate your potential to defeat Tom Petri in November. First, Wisconsin 6th C.D. voters approach this year's election with a clear bias for change and a fresh approach in Washington. By two to one, voters say they prefer electing new people (51%) to Congress rather than reelecting incumbents (26%). Even Petri voters prefer electing someone new by 43% to 33%.

Second, this strong anti-incumbent bias is even more significant given that Tom Petri is clearly perceived as someone who has become too much a part of business as usual in Congress. By 48% to 35%, 6th C.D. voters say they think of Tom Petri more as someone who is "part of the political establishment in Washington" rather than as someone who "works for change in Washington and is willing to shake things up when necessary." It is evident that the recent disclosure of Mr. Petri's 77 overdrafts at the House bank has had a significant impact on his image of being an agent of change in Washington.

Finally, Congressman Petri does not appear to elicit the level of personal loyalty from voters that would enable him to overcome his other problems easily. Mr. Petri receives lukewarm ratings on the "feeling thermometer" scale, which

measures voters' personal feelings toward public figures. Barely half (51%) of voters feel positive toward Petri, which is below average for an incumbent. In addition to lacking the level of popularity most incumbents enjoy, Mr. Petri's feeling scores have little depth. More than two-thirds of voters who are favorable toward Petri give him somewhat positive rather than very positive marks.

*This memorandum is based on a survey conducted between May 7 and 8, 1992, among a representative sample of 402 likely general election voters in Wisconsin's 6th congressional district. The margin of error for this survey is plus or minus 5 points.*

I write in response to the above-numbered complaint made by Rod Nelson, 6th District Republican Committee Chairman.

First, the \$500 payment on August 1, 1992 to Garin-Hart Strategic Research Group represents the purchase of data from a May 1992 poll.

The May 13, 1992 memo is actually a portion of information purchased by the Friends of Peg Lautenschlager - State Committee and was listed accordingly in a filing with the Wisconsin State Elections Board. Polling data gleaned from this poll was purchased also by other organizations with interests in the information. A full listing of those making such purchases can be obtained from Garin-Hart Strategic Research Group, Attention Fred Yang, 1724 Connecticut Avenue, NW, Washington, DC 20009.

Let me further note that the May 13, 1992 memo was first utilized by the Friends of Peg Lautenschlager, Federal Account, for purposes of fundraising in a memo sent to several federal political action committees following my June 16, 1992 congressional campaign announcement.

Second, candidate campaign committee contributions from state assembly and state senate colleagues were listed by me as individual contributions for only one reason: I was told to list them in such a manner by members of the staff of the Federal Election Commission.

I am certain I made three telephone inquiries in this regard.

The first inquiry was made sometime in early July 1992. The original purpose of that call was to determine whether or not such contributions were permissible. At that time, I was told by a member of the FEC staff that the contributions were permissible if they were comprised of funds permissible under FEC rules (which they are). I was further told that the contributions, unless the committee filed as a federal committees, could be no greater than \$1000 per election. I was told that the \$1000 limit applied to both the individual contribution amount and contribution aggregates of the committees for each election. I was told that if the candidate committee contributions exceeded this limit, the committee would be required to file as a federal committees. I was told that since these committees were not federal committees I should not report the contributions as committee contributions, but instead as individual contributions. I was told to include the notation "comprised of permissible funds" when listing such contributions.

My second inquiry, I'm certain, was on August 24, 1992, when I was completing the campaign finance report which needed to be mailed on that date. I was concerned with the listing of these contributions as individual and accordingly decided to again seek advice using the FEC toll-free number. Again I was told that I should list these contributions as individual. During this inquiry I was told by the FEC staff person that if these contributions, as described above, were listed in the contribution from committees section, it would set in motion a process whereby these committees would need to file as federal committees, and given the limited nature of the contributions, this would not be needed.

My third inquiry came later in the day on August 24, 1992, when I was completing the report paperwork at the home of my mother, Pat Lautenschlager, who served as bookkeeper for the campaign. She, too, questioned the committee listings as individual. I again called the FEC inquiry numbers and received the same information, confirming the listing of these contributions as individual.

Never were these contributions listed with "intent...to mislead people into thinking that [I was] receiving a higher percentage of [my] contributions from individuals as opposed to campaign committees."

I believe this complaint is without merit. It describes no violation of law, and certainly neither I nor my campaign committee intended to or received an illegal campaign contribution and neither I nor my campaign committee intended to mislead or deceive anyone in the reporting of contributions.



I would ask Counsel to recommend that the Commission find no reason to believe that the complaint sets forth a possible violation of the Act and, accordingly close the file in this matter.



We do not have authority nor would we accept the suggestion to evaluate the financing or reporting arrangements of our clients under the Act.

In short, we are not properly a respondent in this case, having merely done what it is our business to do: conduct survey research for a fee. Nonetheless, we are prepared to offer any information useful to the agency.

As a political polling organization, we are frequently retained by organizations and/or individuals to conduct surveys to assess the electoral climate on behalf of potential candidates. Garin-Hart Research conducted a survey at the request of Rep. Lautenschlager and other entities on May 7 and 8, 1992, in Wisconsin's sixth Congressional district to assess the viability of her potential candidacy. Rep. Lautenschlager did not officially file for the seat until June 16, 1992.




