REC'D - CIVIL RIGHTS

Dear General Counsel:

I recently inspected copies of the campaign expense report filed by the campaign committee of Warren H. Haggerty, Jr., who was a candidate for Congress from the 6th Congressional District of Pennsylvania during the Primary election of 1992. His campaign committee, Citizens for Haggerty, filed a campaign expense report (enclosed) that was replete with incomplete filing information. I have circled in red ink the areas where there was information missing from the report. This missing information made it difficult to determine the address and occupation of individual campaign donors. Several of these donors, who I have identified from my first-hand knowledge, have received contracts or loans from the city of Reading. Warren H. Haggerty, Jr. has been the Mayor of the city of Reading from 1986 to the present.

Was the missing information on Mr. Haggerty's campaign expense report intentional so that it would be difficult for the average citizen to determine the connection between a contributor and the financial help or business they received from the city of Reading? No one can answer that question but the person or persons responsible for preparing such an incomplete campaign expense report. Nevertheless, all candidates for federal office have an obligation under federal law and regulations to provide accurate and complete information on their campaign expense reports.

I am, as a concerned citizen, filing a complaint before the Federal Election Commission concerning the incomplete and improperly completed campaign finance report filed by the campaign committee "Citizens for Haggerty." I trust my complaint will be promptly adjudicated. I can be contacted at which is an unlisted phone number.

Thank you for the opportunity to help ensure that federal campaign finance law and regulations are fairly applied to all candidates for federal office.

GENERAL COUNSEL'S QUARTERLY REPORT

I. INTRODUCTION

This report is the second Enforcement Priority System Quarterly Report. The purpose of this Quarterly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission approved criteria

By closing such cases the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 16 cases which do not warrant further pursuit relative to the other pending cases.¹ A short


