COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT

5. According to FEC records, respondent Stanley C. Gault made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Stanley C. Gault made contributions attributed to the 1992 calendar year in the amount of \$45,300. These contributions exceeded by \$20,300 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.

This is in response to the complaint filed with the Federal Election Commission by the Center for Responsive Politics.

The occurrence outlined in the complaint arose as a result of a contribution of \$20,000 made to the Republican Leadership Fund on May 18, 1992, for a joint fund raising event. There was confusion and misunderstanding on my part as to how this contribution was to be distributed. As it turned out, \$5,000.00 of the amount was allocated to the Ohio Republican Party federal account which took me over the federal limit.

I did not learn about the situation until the fall of 1993 at which time I asked for a refund to bring me within the federal giving limit for 1992.

Enclosed for your review and consideration are the following materials:

- 1) Copy of my check for \$20,000 to the Republican Leadership Fund with a handwritten note made by the recipient re the original deposit on May 27, 1992, and subsequent transfer between the federal and state accounts.
- 2) Copy of the Republican Leadership Fund report on FEC Form 3P dated July 15, 1992, reporting receipt of the \$20,000.
- 3) Copy of the Ohio Republican Party Campaign Committee State Report dated October 22, 1992, reporting \$15,000 received on May 27, 1992.
- 4) Copy of the Ohio Republican State Central and Executive Committee October 15, 1992, report on FEC Form 3X reporting \$5,000 received on May 27, 1992.
- 5) Copy of my request to the Republican National Committee for a refund of \$5,200 and a copy of the refund check.
- 6) Copy of a refund check for \$200 from the Mike DeWine campaign committee.

After review of this letter and enclosed material, I sincerely hope you will determine that there was confusion and misunderstanding regarding the allocation of my contribution which caused me to inadvertently and unintentionally exceed the federal limit for 1992.







The Republican Leadership Fund ("the Fund") received on February 17, 1994 your letter dated February 15, 1994, regarding this MUR. The Fund was the joint fundraising committee of the Bush-Quayle '92 Primary Committee, Inc., the Ohio Republican Party-Federal Account, and the Ohio Republican Party's Non-federal Account.

The information contained in Exhibits 1 and 2 is incomplete. The Fund received a contribution of \$ 20,000 from Mr. Stanley Gault on May 27, 1992. As permitted by the joint fundraising agreement governing the Fund's receipts, \$ 5,000 was allocated to the Ohio Republican Party-Federal Account, and \$ 15,000 was allocated to the Ohio Republican Party's Non-federal Account. The appropriate transfers to these two participating committees were made on August 14, 1992, and properly disclosed on the Fund's FEC report for the third quarter of 1992. None of Mr. Gault's contribution was allocated to the Bush-Quayle '92 Primary Committee, Inc. Therefore, the Fund is not in violation of any regulation with respect to Mr. Gault's contribution.

The documentation necessary to support the activity referenced above has already been provided to, and verified by, the Commission's Audit Division. As a result, I request that the Commission determine that no action should be taken against the Fund with respect to MUR 3868.

GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is

The Center for Responsive Politics filed a complaint alleging that Stanley Gault exceeded his 1992 \$25,000 annual limit by \$20,300 because his 1992 contributions total \$45,300. The contributions identified in the complaint raised the issue of whether a recipient committee, the Republican Leadership Fund, accepted contributions which exceeded the \$5,000 limit.

In response to the complaint, Mr. Gault states that a \$20,000 contribution which he made to the Republican Leadership Fund was for a joint fundraising event and that \$5,000 of the contribution was attributed to the Ohio Republican Party-Federal Account and \$15,000 was attributed to the Ohio Republican Party's Non-Federal Account. Mr. Gault states that he requested and received a \$5,200 refund from the Republican National Committee and a \$200 refund from the Mike DeWine Campaign Committee, resulting in his 1992 contributions totaling \$24,900.

The Republican Leadership Fund ("Fund") responds that it was a joint fundraising committee for the Bush-Quayle '92 Primary Committee, Inc., the Ohio Republican Party-Federal Account, and the Ohio Republican Party's Non-federal Account.
