COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT

5. According to FEC records, respondent Henry Salvatori made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Henry Salvatori made contributions attributed to the 1992 calendar year in the amount of \$42,650. These contributions exceeded by \$17,650 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.





A. The Commission's Failure to Comply With 2 U.S.C. § 437g(a)(1) Precludes it From Taking Any Action Against Mr. Salvatori in This Matter.

Under Title 2, Chapter 14 of the United States Code, the Commission is required to notify a party that a complaint alleging violation of the Federal Election Campaign Laws has been filed against him within five days of its receipt thereof. The Code provides in pertinent part:

"Within 5 days after receipt of a complaint, the Commission shall notify, in writing, any person alleged in the complaint to have committed such a violation."

(2 U.S.C. § 441g(a)(1).)

CRP's complaint was filed with the Commission on January 21, 1994. The Commission notified Mr. Salvatori of the complaint on January 28, 1994, seven days later. Since the Commission did not notify Mr. Salvatori of the complaint within five days as required by 2 U.S.C. § 441g(a)(1), it is precluded from considering this matter or voting on the complaint. Accordingly, Mr. Salvatori requests that the Commission take no further action against him and close its file in this matter.

B. Alternatively, due to the Facts and Circumstances of this Case, the Commission Should Take no Further Action Against Mr. Salvatori and Close its File in This Matter.

If the Commission determines that it has authority to consider and vote on CRP's complaint notwithstanding its failure to comply with the requirements set forth in 2 U.S.C. § 441g(a)(1), Mr. Salvatori believes that under the facts and circumstances of this case, the Commission should take no further action against him and close its file in this matter.

1. Background Facts

The respondent in this matter is Henry Salvatori, a resident of Los Angeles, California. Mr. Salvatori is 92 years old.

The contributions at issue in this matter were made in 1991 and 1992. In calendar year 1991, Mr. Salvatori contributed \$6,500 to 9 individual candidates. (See, Attached Schedule "A".)¹ In calendar year 1992, he contributed \$11,150 to 12 individual candidates; \$4,000 to a national committee; \$4,500 to a national congressional committee; \$8,250 to a national senatorial committee; and, \$6,000 to other committees. (See, Attached Exhibit "B".)²

¹ In calendar year 1991, Mr. Salvatori made an additional \$1,000 in contributions which were refunded to him.

² In calendar year 1992, Mr. Salvatori also made \$2,750 in contributions to candidates which were refunded to him.



GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is


