COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT


5. According to FEC records, respondent Eugene Applebaum made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Eugene Applebaum made contributions attributed to the 1992 calendar year in the amount of \$39,250. These contributions exceeded by \$14,250 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.

This letter is in response to the Complaint filed against Eugene Applebaum alleging that Mr. Applebaum exceeded the individual contribution limitations imposed under 2 USC § 441a(a)(3); 11 CFR § 110.5. Under 11 CFR § 110.5, no individual may contribute more than \$25,000 in any calendar year ("C.Y."). The complaint alleges that Mr. Applebaum exceed by \$15,250 the contribution limitation for C.Y. 1992. Attached to the Complaint is Exhibit 1, entitled "Summary of FEC Data" which purports to establish the amount and nature of the contributions made by Mr. Applebaum for C.Y. 1992. The Complaint is misleading as Exhibit 1 inaccurately reflects contributions made by Mr. Applebaum for C.Y. 1992.

Specifically, Exhibit 1 reflects a contribution by Mr. Applebaum to the Republican National Committee dated 1/27/92 in the amount of \$15,000. This contribution should not be attributed to Mr. Applebaum as the amount of the contribution was refunded by the Republican National Committee.

The circumstances surrounding the refund of the \$15,000 contribution are well documented. On January 23, 1992 Eugene Applebaum endorsed a check in the amount of \$15,000 payable to the Republican Eagles. The \$15,000 check was from a joint account in the name of Eugene or Marcia Applebaum. It was Mr. Applebaum's intent to sign the check on behalf of his wife. See, the September 28, 1993 letter from Todd A. Wyatt to Mary Thawley attached as Exhibit A. As the result of Mr. Applebaum's failure to execute the check on behalf of his wife, the contribution was attributed to him. Thus, corrective action was taken and Mr. Applebaum requested that the \$15,000 check be returned to him. See, the October 11,





GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is

This Office recommends that the Commission exercise its prosecutorial discretion and no longer pursue the cases listed below effective November 14, 1994. By closing the cases effective November 14, 1994, CED and the Legal Review Team will respectively have the additional time necessary for preparing the closing letters and the case files for the public record for this fairly large number of cases.
