Mathematical errors: (Schedule A, Itemized Receipts).

Beginning on Page 10 of 23 of Schedule A, Itemized Receipts there is a mathematical error in addition of the subtotal. Mr. Lee's account shows \$1,800.00, when it should be \$1,900.00. This is an error of \$100.00 that is carried forward and effects the totals.

Beginning on Page 2 of 6 of Schedule B, Itemized Disbursements there are a series of mathematical errors in addition of the Subtotal. On Page 2 of 6 the error is \$2.00 which is carried on through and accompanied with other errors that effect the totals.

The errors noted above effect the totals and should be corrected by addendum to reflect the correct amounts.



This letter is in response to your letter of August 22, 1994, and the complaint filed against this Committee, and will explain the errors in our July 15, 1994 Quarterly Report, which are the subject of the complaint. Those errors were detected in a subsequent internal audit of our books and reports and an amended July 15, 1994 Quarterly Report was filed on August 24, 1994, before we received your letter.

Our April 15, 1994 Quarterly Report was prepared by hand and timely filed based on our then-knowledge and understanding of the rules and guidelines pertaining to such filings. Prior to the time of filing of the July 15, 1994 Quarterly Report, the Committee engaged the services of Dianna R. Reynolds to computerize our books and records. Ms. Reynolds then prepared and filed the July 15, 1994 Quarterly Report based on the methodology used in preparing the April 15, 1994 Quarterly Report.

On July 16, 1994, we received a letter from the Reports Analysis Division (dated July 14, 1994) regarding our April 15, 1994 Quarterly report, which requested that certain corrections be made and an amended report filed. Based on that letter, we filed an amended April 15, 1994 Quarterly Report on August 10, 1994.

On August 18, 1994, we received a letter regarding the July 15, 1994 Quarterly Report, which again requested certain corrections be made to that report. Based on these two letters, we conducted an internal audit of all of our books and records and filed a second amended April 15, 1994 Quarterly Report and a first amended July 15, 1994 Quarterly Reports on August 24, 1994, the

day we received notification of the complaint. I enclose copies of both of these amended reports for your review.

I trust this explanation will be sufficient in disposing of this complaint. The fact is, these errors were simply human oversights and were not intentional efforts to file misleading or fraudulent reports. In addition, we have amended our Statement of Organization to list Ms. Reynolds as our Assistant Treasurer (copy enclosed) so that she may be made immediately aware of any problems arising out of the filing of our reports. I would request that she be copied directly on any further communications from your office.



GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is

On August 22, 1994, the Federal Election Commission notified you of a complaint alleging certain violations of the Federal Election Campaign Act of 1971, as amended. A copy of the complaint was enclosed with that notification.

After considering the circumstances of this matter, the Commission has determined to exercise its prosecutorial discretion and to take no action against Buck Lee for Congress and you, as treasurer. See attached narrative. Accordingly, the Commission closed its file in this matter on November 14, 1994.

The confidentiality provisions of 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. In addition, although the complete file must be placed on the public record within 30 days, this could occur at any time following certification of the Commission's vote. If you wish to submit any factual or legal materials to appear on the public record, please do so as soon as possible. While the file may be placed on the public record prior to receipt of your additional materials, any permissible submissions will be added to the public record when received.

Ralph Perkins filed a complaint alleging that the "Buck" Lee for Congress Committee omitted the names and occupations for three contributors who made contributions in excess of \$200 in its 1994 July Quarterly Report and that the July Quarterly also contained a mathematical error of \$100 in the subtotal for receipts.

In response to the complaint, the Committee states that the Reports Analysis Division had contacted the Committee regarding these omissions and the error and that the Committee had filed two amendments to its report in order to make corrections. The Committee states that the first amendment was filed prior to the complaint being filed and the second amendment was filed the day that the Committee received the complaint notification.

This matter involves insubstantial amounts of money and less significant issues relative to other matters pending before the Commission. Remedial action was taken in this matter.
