

GENERAL COUNSEL'S REPORT

Background

On March 17, 1978, the Disclosure Division referred this candidate to the Office of General Counsel for review following his failure to file a Statement of Candidacy due January 17, 1978, pursuant to 2 U.S.C. §433, to designate a principal campaign committee due January 27, 1978, pursuant to 2 U.S.C. §432(e), or to file a ten day pre-primary report due March 11, 1978, pursuant to 2 U.S.C. §434(a)(1).

Analysis

On March 22, 1978, respondent Daly filed a Statement of Candidacy. On April 18, 1978, Lar Daly died. The respondent never designated a principal campaign committee nor was the ten day pre-primary report ever filed.

Recommendation

Because of Mr. Daly's death, we recommend the Commission take no further action in this matter and close the file.
