

GENERAL COUNSEL'S REPORT

Background

On April 4, 1978, the Disclosure Division referred to the Office of the General Counsel the names of thirteen multicandidate committees who had failed to file their 1977 year-end report with the Federal Election Commission. For each of the thirteen committees the Commission found reason to believe and reasonable cause to believe that 2 U.S.C. § 434 had been violated. Attempts were made to notify each respondent of the Commission's findings.

Analysis

The Office of the General Counsel reviewed all the reports filed by these multicandidate committees. Subsequent to the referral by the Disclosure Division, 1977 year-end reports were filed by Footwear Industry PAC, Georgia League of

Conservation Voters, Michigan Conservative Union, and Machinist Non-Partisan Political League District 727 Chapter. Of the remaining nine committees, none reported receipts and/or expenditures which exceeded \$5,000 during 1977. In fact, the largest amount reported during 1977 was receipts of \$1,481 by Georgia Nursing Homes Education and PAC. It appears at this time that none of the remaining committees have any significant outstanding debts.

RECOMMENDATION

In view of these facts, we recommend that the Commission take no further action with regard to these respondents and that the file be closed.




