GENERAL COUNSEL'S REPORT

I. BACKGROUND

On January 16, 1978, the Reports Analysis Division referred to the Office of General Counsel two non-party related committees which failed to file 1976 and 1977 Year-End Reports as required by 2 U.S.C. § 434(a)(1).

II. SUMMARY OF ALLEGATION

With regard to the two Committees the Commission has made the following determinations:

United Nations Reform Electoral Campaign Committee (UN Committee)

1. 1976 Year-End Report - RTB 04/01/77
RCTB 10/28/77
2. 1977 Year-End Report - RTB 02/15/78
RCTB 03/08/78

Sportsmen For Kentucky Committee (Sportsmen Committee)

1. 1976 Year-End Report - RTB 04/01/77
RCTB 10/28/77

III. FURTHER DEVELOPMENTS

On May 3, 1978, the Commission determined to take no further action with regard to the U.N. Committee's failure to file the 1977 Year-End Report (MUR 565), due to insignificant outstanding debts and minimal financial activity. The Committee has filed 3a postcards for the 1977 Quarterly Reports and the April 10, 1978 Quarterly Report. Due to the circumstances of minimal financial activity and compliance with the Act, the Office would advise the Commission not to pursue the U.N. Committee with regard to the 1976 Year-End Non-Filing Status.


The Sportsmen Committee filed the 1977 Year-End Report on January 23, 1978. This report listed total receipts in the amount of \$482.60, expenditures in the amount of \$1,065.88 and no outstanding debts and obligations. In addition, the Committee filed a 3a postcard for the April 10, 1978 Quarterly Report. Utilizing the guidelines set out in the Report of Task Force on Non-filing Procedures dated May 23, 1978 (paragraph VIII B, page 8), the Sportsmen Committee does not meet the specified criteria for further action by the Commission.

RECOMMENDATION

It is recommended that the Commission take no further action with regard to these committees. Close the file.
