

GENERAL COUNSEL'S REPORT

Background

In a notarized complaint dated July 19, 1978, complainant Mary A. Scheckelhoff alleged that the respondent, Committee to Elect Don Albosta to Congress, had failed to report campaign related travel expenses for the candidate and/or his family and staff in the quarterly reports filed with the Commission in January, April and July of this year. On August 9, 1978, the Commission adopted the recommendation of the General Counsel and found reason to believe that the Committee to Elect Don Albosta to Congress (hereinafter "the Committee") violated 11 C.F.R. §106.3(a).

Analysis


On August 30, 1978, the Committee filed with the Commission copies of amended reports relating to travel expenses incurred by the candidate in accordance with 11 C.F. R. §106.3(a). (Attachment)






