GENERAL COUNSEL'S REPORT

ALLEGATIONS

2001011777
A review of the reports filed by the West Virginia Republican State Executive Committee (the "Committee") by the Reports Analysis Division revealed that the Committee appeared to violate 2 U.S.C. §434 because it omitted the principal place of business for some contributors; it omitted information regarding "travel expenses" and "expenses"; and it did not account for \$37,707.53 cash on hand which the Committee had at its inception on October 17, 1977. This matter was referred to the Office of General Counsel from the Reports Analysis Division on September 15, 1978 (Attachment I).

PREVIOUS COMMISSION ACTION AND EVIDENCE

The Committee was notified of the alleged surface violations on March 16, 1977. The Committee, in a letter to the Commission dated April 10, 1978, provided the principal place of business for the contributors in question and stated the exact purpose of the "expenses" and "travel expenses".

In response to the question of the \$37,707.53 cash on hand at its inception, the Committee stated that the money was acquired through two direct fund raising mailings in 1976 and 1977. The Committee was notified in a letter, dated May 1, 1978, that their explanation of the cash on hand was inadequate and that the Committee should file a Schedule D to further explain the two fundraising events. The Commission on June 21, 1978, found reason to believe that the Committee violated 2 U.S.C. §434 for failing to explain the cash on hand.

LEGAL ANALYSIS

2 U.S.C. §434 requires that the Committee disclose on their reports all individuals who contributed an aggregate amount in excess of \$100 to the Committee. The Committee, in their letter of April 10, 1978, did not state whether the \$37,707.53 cash on hand included any contributions from individuals in excess of \$100. While this information, and possibly other details surrounding the mailings, should have been supplied by the Committee, the Request for Additional Information dated May 1, 1978, requested that the Committee submit a Schedule D to explain the \$37,707.53 cash on hand. Schedule D is generally used to report receipts from sales and collections at fundraising events, and as such, it was inappropriately suggested as the form to explain the Committee's mailings.

The Audit Division is planning to audit this Committee. The tentative date for the audit to begin is November 13, 1978. In light of the fact that the Request for Additional Information sent to the Committee on May 1, 1978 inappropriately suggested

the use of Schedule D and the fact that the Audit Division will audit the Committee in the near future, we think that no further action should be taken at this time.


RECOMMENDATION
