



GENERAL COUNSEL'S REPORT

On December 7, 1978, the Commission found reason to believe that the Sasser for Senate Committee violated 2 U.S.C. § 441b(a) by accepting corporate contributions during the 1976 campaign. The following businesses were found to be in violation of 2 U.S.C. § 441b(a) for making corporate contributions in connection with a federal election: Billy Joe Childress Construction Company, Ervin Supply Corporation, and the Varsity Club. The violations were discovered during a routine audit of the Sasser for Senate Committee.

As reported previously, the Sasser for Senate Committee provided documentation from the Tennessee Secretary of State or the principal representatives of the contributing companies which appeared adequate to verify the source of contributions. The documents indicate that only \$500 of \$7,197 in questioned contributions actually represented corporate funds. The balance was drawn on bank accounts of unincorporated firms, partnerships, or accounts containing no corporate monies. The Committee has refunded this amount to the corporations and has reported the refunds on disclosure reports.

As the Committee made thorough efforts to determine the source of contributions and made prompt refunds when corporate monies were discovered, we recommend that no further action be taken against the Committee.

The corporate respondents received notification of the finding against them. Mr. Billy Joe Childress, President of the Billy Joe Childress Construction Company, contacted this Office by telephone and later stated in a notarized letter that it was his understanding that the Act allowed a corporate contribution not exceeding \$100 (the amount of his donation). He enclosed a copy of the check to illustrate that it did not identify the company as a corporation.

Mr. J. L. Ervin, President of the Ervin Supply Corporation, submitted a notarized letter explaining his corporation's involvement in this matter. He stated that the check was made payable to Mrs. Barbara Ervin for a service to the company. She then endorsed the check to the Sasser Committee. Respondent states that Mrs. Ervin is not an officer or regular employee of the company.

Mrs. Ervin had spoken with this Office by telephone to explain her role in this transaction. She assured us that the contribution was intended as a personal gift and was not from the Ervin Supply Corporation.

When we were unable to notify the Varsity Club by mail, we reached the respondent by telephone. Mr. Fred Williams,

owner, stated that he was not aware of the Act's requirements, but that he had received a refund from the Committee.

The information gathered from respondents' statements indicates that no knowing violation occurred in these cases. As corporate monies were refunded, we are recommending that no further action be taken against the respondents.

RECOMMENDATIONS

1. Take no further action against the Sasser for Senate Committee regarding the violation of 2 U.S.C. § 441b(a).
2. Take no further action against the Billy Joe Childress Construction Company regarding the violation of 2 U.S.C. § 441b(a).

4. Take no further action against The Varsity Club regarding the violation of 2 U.S.C. § 441b(a).







GENERATION OF MATTER

This matter was referred to the Office of General Counsel by the Audit Division as a result of a random audit of the Sasser for Senate Committee.

SUMMARY OF ALLEGATIONS

Billy Joe Childress Construction Company, Ervin Supply Corporation, and the Varsity Club violated 2 U.S.C. § 441b(a) by making contributions to the Sasser for Senate Committee.

The Sasser for Senate Committee violated 2 U.S.C. § 441b(a) by accepting corporate contributions in connection with a Federal election.

LEGAL ANALYSIS

During the audit of the Sasser for Senate Committee ("the Committee"), auditors discovered 27 contributions from 21 apparent corporations. The auditors advised the Committee to refund all corporate contributions or provide evidence to show that the contributions were not from corporate sources.

In response, the Committee reviewed its records and contacted both the Secretary of State's Office and the contributors to determine which monies were refundable. According to the Committee, only \$500 of the \$7,197 in questioned contributions actually represented corporate funds. The Committee has refunded this amount to the corporations and has reported the refunds on disclosure reports.

For each contribution, the Committee obtained verification from the Tennessee Secretary of State or a signed statement from the principal representative of the contributing company. These efforts revealed that 22 questioned contributions totalling \$6,697 were drawn on accounts of unincorporated firms, partnerships, or accounts containing no corporate monies.

The Committee bookkeeper advised the auditors that it was the Committee's practice to verify the corporate status of contributions received from business entities by contacting the appropriate Secretary of State by telephone. Memoranda of these conversations was not maintained.

When the information was received, the Audit Division referred this matter to the Office of General Counsel for review. Our examination of the documents indicates that the Committee made thorough efforts to obtain the necessary verification of corporate status, and made prompt refunds when corporate monies proved to be the source of contributions. The statements from principals of businesses and the Tennessee Secretary of State's letter appear adequate to show the source of contributions. Only statements from the corporations are not included in the documents.

Therefore, we recommend that the Commission find reason to believe that violations of 2 U.S.C. § 441b(a) occurred by the contribution and receipt of corporate monies.

1. Find reason to believe that the Sasser for Senate Committee violated 2 U.S.C. § 441b(a).
2. Find reason to believe that the Billy Joe Childress Construction Company violated 2 U.S.C. § 441b(a).

Receipt of Corporate Contributions

Section 441b(a) of Title 2 of the United States Code states, in part, that it is unlawful for any corporation to make a contribution or expenditure in connection with any Federal election to political office, and it is unlawful for any candidate, political committee, or other person to knowingly accept or receive any such contributions from a corporation.

A review of the Committee's contribution records including copies of contributor checks and verification with the appropriate Secretaries of State, indicated that 21 corporations made 27 contributions, totaling \$7,197, to the Sasser for Senate Committee (see Attachment I).

During the audit, we were advised by the Committee bookkeeper that the corporate status of contributions received from business entities was verified by telephone with the appropriate Secretary of State. However, memoranda pertaining to the verifications was not retained by the Committee.

Based on the Audit staff's recommendation that the Committee refund the corporate contributions, or provide evidence that the contributions were not funded from corporate sources, the treasurer submitted copies of five (5) Committee checks used to refund five (5) of the contributions totaling \$500.00. In addition, the treasurer provided written documentation which, in his opinion, demonstrates that the remaining 22 contributions totaling \$6,697.00 were not funded from corporate sources. Enclosed is the response of the Sasser for Senate Committee to the Commission's letter of June 21, 1978. We have made our best efforts to comply with the Commission's recommendations. While this response contains most of the information requested by the Commission, we are still receiving material in answer to some of our requests. In particular, although we have made repeated inquiries, we have not collected all of the receipts for expenditures by the Committee. We will continue to submit these receipts as we receive them.

In addition, we have now completed our review of contributions which the Commission considered as possibly from corporations. The Commission identified 27 contributions totalling \$7,197.00. Upon review, we have determined that \$610 (8 contributions) should be refunded. We have submitted records demonstrating that the other contributions are not from corporations. Refund checks have been mailed (Copies of the checks with an explanation are enclosed.); we will supply copies of cancelled checks when we receive them.

As explained to you in our letter of May 11, 1978, the Committee made extensive efforts to



Receipt of Corporate Contributions

Section 441b(a) of Title 2 of the United States Code states, in part, that it is unlawful for any corporation to make a contribution or expenditure in connection with any Federal election to political office, and it is unlawful for any candidate, political committee, or other person to knowingly accept or receive any such contributions from a corporation.

A review of the Committee's contribution records including copies of contributor checks and verification with the appropriate Secretaries of State, indicated that 21 corporations made 27 contributions, totaling \$7,197, to the Sasser for Senate Committee (see Attachment I).

During the audit, we were advised by the Committee bookkeeper that the corporate status of contributions received from business entities was verified by telephone with the appropriate Secretary of State. However, memoranda pertaining to the verifications was not retained by the Committee.

Based on the Audit staff's recommendation that the Committee refund the corporate contributions, or provide evidence that the contributions were not funded from corporate sources, the treasurer submitted copies of five (5) Committee checks used to refund five (5) of the contributions totaling \$500.00. In addition, the treasurer provided written documentation which, in his opinion, demonstrates that the remaining 22 contributions totaling \$6,697.00 were not funded from corporate sources. Enclosed is the response of the Sasser for Senate Committee to the Commission's letter of June 21, 1978. We have made our best efforts to comply with the Commission's recommendations. While this response contains most of the information requested by the Commission, we are still receiving material in answer to some of our requests. In particular, although we have made repeated inquiries, we have not collected all of the receipts for expenditures by the Committee. We will continue to submit these receipts as we receive them.

In addition, we have now completed our review of contributions which the Commission considered as possibly from corporations. The Commission identified 27 contributions totalling \$7,197.00. Upon review, we have determined that \$610 (8 contributions) should be refunded. We have submitted records demonstrating that the other contributions are not from corporations. Refund checks have been mailed (Copies of the checks with an explanation are enclosed.); we will supply copies of cancelled checks when we receive them.

As explained to you in our letter of May 11, 1978, the Committee made extensive efforts to
