The subject MUR raises the possibility of a violation of 18 U.S.C. § 613, which prohibits the solicitation of contributions from foreign nationals, and over which we have enforcement authority. The problem is that the only way we could obtain additional information would be to ask the reporter who wrote the story, a move which would undoubtedly result in misleading and unfairly damaging publicity to the effect that we are "investigating" Bentsen. Since the allegations are vague and we have received no complaint, I do not think that proceeding further on this matter would be worth the aforementioned risk. I therefore recommend that we close this case.

A. Allegation

This matter comes before the Commission not as a complaint, but by virtue of articles appearing in New Times and Political Intelligence which were drawn to the attention of AID staff by a reporter. The articles allege that a campaign aide to Senator Bentsen solicited contributions from a representative of a "Mediterranean country".

B. Evidence

The articles present no evidence in support of this allegation.

C. Analysis and Recommendations

The subject MUR raises the possibility of a violation of 18 U.S.C. §613, which prohibits the solicitation of contributions from foreign nationals, and over which we have enforcement authority. The problem is that the only way we could obtain additional information would be to ask the reporter who wrote the story, a move which would undoubtedly result in misleading and unfairly damaging

BENTSEN FUND-RAISERS FLOUT CAMPAIGN LAW. Dem Presidential hopeful Lloyd Bentsen espoused the cause of a certain Mediterranean country in recent key Senate debates. His position seemed to be based on his own convictions. Then, a campaign staff fund-raiser called a representative of that country, cited Bentsen's efforts and asked for a campaign contribution in return. He said he had been told to call by two higher-ups on the Bentsen staff who had served in previous Democratic administrations. The idea of a quid pro quo may seem bad enough, but soliciting funds from foreign nationals is a violation of Federal law subject to a \$25,000 fine and as much as 5 years in jail. The representative of the foreign government was sturned by the request and warned Bentsen's man off the attempt. Given Bentsen's prodigious ability to raise campaign funds, this case raises questions about other sources of his support.

Father knows best?

Ronald Reagan's syndicated radio program, heard nationally on 320 stations each day, was the occasion for an intrafamily squabble recently. With Reagan out barnstorming these

days, daughter Maureen sometimes pinch-hits on the show, generally toeing the conservative family line.

But one issue that Maureen feels strong progressive instincts about is the Equal Rights Amendment, and she requested last month that she be able to air her views on the show. Reagan was taken aback; he supported the ERA during his tenure as governor, but has backed off in the last year on what he says are legal grounds.

A compromise was reached when Reagan told his daughter that she could air her viewpoint on one show and he would present the opposite position on the next. Maureen defended the ERA, which is still four states shy of passage, by pointing out that it is the most crucial element in the drive for women's equality. Her dad came back gently but firmly: "My daughter Maureen . . . finds it hard to believe that I can be for women's equality without being for ERA. It's true . . . I believe the ERA would take away laws that were passed especially to make sure that women were not put upon by men."

executives revealed that three out of five believe their subordinates would commit the unethical acts characteristic of Watergate in order to show loyalty to the boss. University of Georgia professor Archie Carroll reports that a majority of the executives also said that recently revealed illegal campaign contributions by large corporations are "realistic examples" of current business ethics.

Bentsen: fund-raizing

In recent months, Senator Lloyd Bentsen of Texas has espoused the cause of a certain Mediterranean country in key Senate debates. His sentiments seemed to come from the heart. But now one wonders if they did not derive from a more mercenary motive. Recently, one of Bentsen's staff fund-raisers called a representative of the country, cited Bentsen's efforts in its behalf and asked for a campaign contribution in return. The caller said that his request had been cleared with two higher-ups on the staff. The idea of a quid pro quo may seem bad enough, but soliciting funds from foreign nationals is a violation of the federal law—subject to a \$25,000 fine and up to five years in jail. The representative of the foreign government, who insisted on anonymity, was stunned by the request and warned Bentsen's man off. Nonetheless, an illegal act had been committed and the case can only raise more questions about the means by which Bentsen's campaign is funded.

The Kissinger tapes

Henry Kissinger has a new diversion in between shuttle diplomacy stops: muttering into a tape recorder he carries with him. Reporters traveling with Kissinger at first assumed the Secretary of State was simply collecting his thoughts for upcoming diplomatic sessions. But leave it to Henry to stay one step ahead. In fact, he is beginning work on his memoirs.

Speechless

The fervor with which Congress passed its strict Campaign Reform Act in the aftermath of Watergate last year is wearing thin.

One of the law's provisions is that members of Congress cannot accept more than \$15,000 in honoraria for speeches and articles during any

Now, members of Congress who sole outside income comes from speeches and articles have found the law is discriminatory. Their associates, who moonlight as lecturers and businessmen, for instance, are free to earn as much as they can on the outside. Sources say a compromise has been reached. By the end of the year, the limit will simply be lifted—making everyone happy.

The same thing could happen to a surprisingly tough new regulation proposed by the Federal Election Commission recently. They have asked for a crackdown on congressional office accounts, and the legislators are balking. Senate leaders Mansfield and Scott and five others signed a letter to the Commission recently asking that the rule be toned down. Congressional members now use the funds for extra staff, travel, Christmas cards, funeral flowers, interns' expenses and other ostensibly "non-political" outlays. Observers say that it's an even bet that Congress will veto the rule in the 30 working days it has to do so.

- 5) 3 committees that failed to provide adequate disclosure of receipts and expenditures as required by 2 U.S.C. 434; in addition to a copy of each report in question is attached a copy of a request that such report be amended to meet the disclosure requirements of the Act, as well as any response received from such request (Group E).

The referrals attached hereto reference the period of the 1974 primary and general elections through the March 10, 1975 report.
