GENERATION OF MATTER

On 11 May 1979, the Reports Analysis Division referred this matter involving the apparent acceptance of a union contribution to the Office of General Counsel. (See Attachment #1.)

EVIDENCE

A review of the 1978 reports filed by the Lindy Boggs Campaign Committee disclosed receipt of \$125 on 2 March 1978 from the United Slate, Tile and Composition Roofers Local #141, which violated 2 U.S.C. §441b. The Commission notified the Committee of the apparent violation by letter dated 1 March 1979. The Committee submitted an adequate response on 16 March 1979, stating that the contribution was refunded on 8 March 1979.

PRELIMINARY LEGAL ANALYSIS

The contribution in question was made and accepted prior to August, 1978 when the Commission notified candidates and committees that the acceptance of §441b contributions might result in the imposition of civil penalties. Since the recipient Committee promptly responded to the Commission's notification by refunding the contribution, we think the file should be closed and no further action taken against the respondents.

In connection with this closing, we recommend that letters of admonition be sent to the Committee and Local #141, for the contributor has not received notification from the Commission as to the illegal nature of the contribution.

Dear Mr. Kohlmeier:

This letter is prompted by the Commission's interest in assisting candidates and committees who wish to comply with the Federal Election Campaign Act, as amended. During review of the April 10 Amended Report of Receipts and Expenditures, we noticed an entry indicating that you may have accepted a contribution from a union. Union contributions are prohibited by the Act, unless the contribution is made by a separate segregated fund established by the union. A copy of that portion of your report is attached for your review and clarification.

The Commission recommends that if you have accepted a prohibited contribution that you return the full amount to the donor. The return of the contribution should be reported immediately by letter and should be reflected as a contribution refund on your next report of receipts and expenditures. If the identification of the source of this contribution is incomplete or incorrect on the original report, please submit a statement which would clarify this particular matter for the public record. You may do so by amending your original report by letter.

Please notify the Commission within fifteen (15) days from the date of this letter of the determination made on this matter. If you have any questions concerning this matter, please do not hesitate to contact Susan Kaltenbaugh (800) 424-9550, our Reports Analyst assigned to you. Our local telephone number is 503-4172.

Dear Ms. Kaltenbaugh:

This is in reply to Mr. Orlando B. Potter's letter of March 1, 1979, and other correspondence I have received from the Commission requesting further information.

The United Tile and Composition Roofers Local Number 141 has checked their records and found that they sent us a union check, which we have refunded, as per the attached letter.

A check of the records of Construction and General Laborers Union Local Number 689 shows that the check came from their C.O.P.E. and was inadvertently listed by us as from the union, instead of its C.O.P.E.

The donation from Coleman, Dutrey, Thomson, Meyer & Jurisich for \$500 was from Mr. James J. Coleman, Sr., attorney, in accordance with his letter, a copy of which is attached. The check for \$250 from Mullins & Prichard Oil was a contribution from Mr. James D. Mullins, oil producer. The one for \$125 from Duke & Porterie was from Mr. Louis Porterie, attorney.

One of our previous reports shows in error a check from the University of New Orleans for \$250. Actually, this check came from Dr. Jerome Dickhaus, Vice Chancellor of the University, from Les Aimes de Radio Publique. Since it was received by a University check, it was inadvertently recorded as from the school, instead of the agency. (See attached letter.)

The \$1,000 check received from Lemle, Kelleher, Kohlmeyer & Matthews is from all partners of the firm; and they refuse to break it down, as per their attached letter.

There was a fund raising activity sponsored for Mrs. Boggs by her Campaign Committee on Friday, February 10, 1978, at 7:00 p.m. at the New Orleans Hilton Hotel in New Orleans, Louisiana. Ticket price was \$125 per person. The purpose of the party was to raise funds for Mrs. Boggs' upcoming election. The total gross proceeds of this event were \$50,545.00. These receipts are itemized by donors in these reports. Schedule D is enclosed.

One of our previous reports shows in error a campaign receipt from George P. Ballum. This is incorrect. It should read \$625 from Mr. Ballum, who is an attorney, and \$625 from his client, Dr. Margit Zoller, 4524 Marque Drive, New Orleans, a physician.





This letter is prompted by the Commission's interest in assisting candidates and committees who wish to comply with the Federal Election Campaign Act, as amended. During review of the April 10 Amended Report of Receipts and Expenditures, we noticed an entry indicating that you may have accepted a contribution from a union. Union contributions are prohibited by the Act, unless the contribution is made by a separate segregated fund established by the union. A copy of that portion of your report is attached for your review and clarification.

The Commission recommends that if you have accepted a prohibited contribution that you return the full amount to the donor. The return of the contribution should be reported immediately by letter and should be reflected as a contribution refund on your next report of receipts and expenditures. If the identification of the source of this contribution is incomplete or incorrect on the original report, please submit a statement which would clarify this particular matter for the public record. You may do so by amending your original report by letter.

Please notify the Commission within fifteen (15) days from the date of this letter of the determination made on this matter. This is in reply to Mr. Orlando B. Potter's letter of March 1, 1979, and other correspondence I have received from the Commission requesting further information.

The United Tile and Composition Roofers Local Number 141 has checked their records and found that they sent us a union check, which we have refunded, as per the attached letter.

A check of the records of Construction and General Laborers Union Local Number 689 shows that the check came from their C.O.P.E. and was inadvertently listed by us as from the union, instead of its C.O.P.E.

The donation from Coleman, Dutrey, Thomson, Meyer & Jurisich for \$500 was from Mr. James J. Coleman, Sr., attorney, in accordance with his letter, a copy of which is attached. The check for \$250 from Mullins & Prichard Oil was a contribution from Mr. James D. Mullins, oil producer. The one for \$225 from Duke & Porterie was from Mr. Louis Porterie, attorney.

One of our previous reports shows in error a check from the University of New Orleans for \$250. Actually, this check came from Dr. Jerome Dickhaus, Vice Chancellor of the University, from Les Aimes de Radio Publique. Since it was received by a University check, it was inadvertently recorded as from the school, instead of the agency. (See attached letter.)

The \$1,000 check received from Lemle, Kelleher, Kohlmeier & Matthews is from all partners of the firm; and they refuse to break it down, as per their attached letter.

There was a fund raising activity sponsored for Mrs. Boggs by her Campaign Committee on Friday, February 10, 1978, at 7:00 p.m. at the New Orleans Hilton Hotel in New Orleans, Louisiana. Ticket price was \$125 per person. The purpose of the party was to raise funds for Mrs. Boggs' upcoming election. The total gross proceeds of this event were \$50,545.00. These receipts are itemized by donors in these reports. Schedule D is enclosed.

One of our previous reports shows in error a campaign receipt from George P. Ballum. This is incorrect. It should read \$625 from Mr. Ballum, who is an attorney, and \$625 from his client, Dr. Margit Zoller, 4524 Marque Drive, New Orleans, a physician.




