PAC SUPPORT OF INCUMBENTS INCREASES IN '84 ELECTIONS

WASHINGTON — Incumbents received approximately 72% of all political action committee money contributed during the 1983-84 election cycle, according to a Federal Election Commission study of PAC financial activity released today.

Challengers received only 16%; open-seat races, still less, at 11%.

With PAC contributions to Senate, House and Presidential candidates totalling \$112.6 million, (including \$7.7 million given to retire debts from previous elections or to prepare for future races,) Senate and House incumbents received a total of \$80.5 million, regardless of whether or not they were candidates for re-election in 1984. Those who were involved in re-election efforts received \$74.8 million out of that total.

Incumbent House Democrats received the lion's share - \$38.8 million, which was 34% of all PAC contributions made.

The distribution between candidates of the two major parties was:
Democrats - \$63.9 million (56.7%) and Republicans - \$48.7 million (43.2%).

Although PAC contributions to federal candidates continued to rise, the rate of increase slowed dramatically over previous years. An 18-month study of the '84 elections, issued earlier by the FEC, showed '84 contributions increasing by 50%. However, by the end of the election cycle, a comparison with prior elections shows only a 28.5% increase. Comparison figures, in millions of dollars, appear below:

The FEC study looked at 4,345 PAC's which were involved in the 1983-84 election cycle. By the end of 1984, only 4,009 PAC's remained in existence, and only 3,006 PAC's actually made contributions to federal candidates.

PAC's began 1983 with \$31.7 million cash-on-hand. They raised an additional \$288 million and spent a total of \$265 million. As of December 31, 1984, they had \$55.1 million cash-on-hand and were \$9.4 million in debt. Comparable figures for previous election cycles appear on the next page.

PAC contributions to the two major parties increased from \$6 million in 1982, to \$10.4 million in 1984.

Independent Expenditures by PAC's totalled \$22.2 million, most of which was spent on behalf of presidential candidates.


