PAC'S GIVE \$73 MILLION TO 1991-92 CONGRESSIONAL CAMPAIGNS

WASHINGTON -- Political action committees contributed \$73 million to federal candidates during the first 15 months of the 1991-92 election cycle, up \$9 million or 14 percent over the same period in the previous cycle, according to the Federal Election Commission.

An FEC compilation of the activities of 4,477 registered PAC's shows that these committees raised \$226 million and spent \$188 million from January 1, 1991 through March 31, 1992. PAC's left the period with \$139 million cash-on-hand.

Overall, PAC's contributed \$63.7 million to incumbents, \$3.4 million to challengers and \$6.4 million to open seat candidates in both U.S. Senate and U.S. House races. Democratic congressional candidates received \$48.6 million and Republican candidates received \$24.6 million from PAC's during the period. PAC's also reported giving \$11.4 million to national, state and local political party committees involved in federal elections. Forty-five percent of all PAC's reported making no contributions to federal candidates.

Corporate PAC's led all categories in terms of contributions to federal candidates by giving \$29 million, followed by trade/membership/health, \$20 million; labor, \$14.7 million; non-connected, \$6.5 million; corporations without stock, \$1.7 million and cooperatives, \$1 million.

The statistical tables on the following pages provide comparative data on PAC activity for several election cycles. The first table compares 15-month totals for the 1992, 1990, 1988 and 1986 elections. The second shows PAC contributions by candidate status (incumbent, challenger, open seat) for 1977-78 through 1991-92. The last table details contributions by PAC's during the current cycle, including statistics for PAC activity with regard to all federal candidates and the contributions made only to those candidates seeking election this cycle. (Several million PAC dollars are contributed each cycle to candidates retiring previously incurred debt or raising funds for future elections.)

"Top 50" rankings of the largest PAC's follow the tables.

NOTE: PAC figures and percentages on this release differ from those on the FEC's summary of 15-month congressional activity. Unlike the congressional compilation, this PAC compilation relies on information reported by PAC's. While PAC's may have reported making contributions, candidate committees may not have to report receipt of those funds until the next filing deadline. Also, the line on campaign reports indicating PAC receipts may include money from other sources, such as state and federal candidates' committees.
