1994 CONGRESSIONAL RACES RAISE OVER \$170 MILLION -Campaigns set record for non-election year fundraising activity-

WASHINGTON -- Candidates for 1994 U.S. Senate and House seats have raised and spent a record \$170.7 million and \$102.5 million, respectively, continuing a pattern of early fundraising seen in recent election cycles.

The additional \$11 million raised in 1993 represents a 7% increase over 1991 levels, while the rise in spending of \$13 million is a 15% increase over 1991. While growth in early financial activity has been seen in previous cycles, it did not necessarily result in increases over an entire cycle. Nonetheless, the increased activity for 1993 follows an extremely active 1992 election, created, in part, by factors such as redistricting, a high number of House departures, several special Senate elections and two California Senate races.

Retirements and decisions to seek other political offices have already created an abundance of open-seat races. Open seat races contribute to increased spending in an election cycle.

From January 1, 1993, through December 31, 1993, U.S. Senate and House candidates raised \$170.7 million and spent \$102.5 million. They entered the election year with \$121.4 million cash-on-hand.

The following compares non-election year activities for all Senate and House campaigns in the last four cycles:

Charts on pages three and four of this release separately detail comparison figures for Senate and House campaigns in non-election years from 1987 to 1993.

Candidates for U.S. Senate raised \$75.9 million, spent \$40.4 million, and had \$48.1 million cash-on-hand on December 31, 1993. Comparisons of Senate races between cycles is difficult due to the different nature of the states involved.

In House contests, receipts were reported at \$94.8 million, spending at \$34.8 million, and cash-on-hand, \$45.4 million at year's end.

There are notable differences in the sources of funds raised by Congressional candidates at this point in the current election cycle. Candidates are drawing greater financial support from individuals and from themselves than from PAC's. Contributions from individuals totalled \$100.5 million or 59% of monies raised. Candidate money, either in the form of direct contributions or loans, totalled \$13.6 million - 8% of total revenues. PAC money accounted for \$48.9 million, or 29%. In 1991, individuals accounted for 55% of all receipts; candidates, 6%; and PAC's 33%.

This release contains summary tables on all U.S. Senate and House candidates registered thus far. Comparison summary figures for previous non-election years are also provided. A six-year financial summary is given for each Senate candidate, as well as the 1987 non-election year activity (the last time these seats were contested) in these same states. Each House candidate who raised or spent money during 1993 is listed, followed by rankings of all Senate and House candidates in categories of monies raised and spent, amounts received from individuals and PAC's, cash-on-hand, and debts.

FOOTNOTES

1. Figures in the first two Tables and the detailed listing of candidates cover from January 1, 1993 or whenever the campaign registered during the year through December 31, 1993 or the last report filed by the campaign as indicated.
2. Net receipt and net disbursement figures are total receipts and total disbursements, as reported by the campaigns, minus any money transferred between committees of the same campaign.
3. Columns entitled "other Cmte Contributions" are monies contributed to campaigns by PACs and other committees as reported by the campaigns. Other committees include primarily committees of other candidates.
4. On the Senate listings, the column titled "Candidate Support" includes contributions by the candidate as well as loans made or guaranteed by the candidate. The column titled "trans from other auth" includes monies transferred from House committees of candidates for the Senate, as well as proceeds from joint fundraising activity among several candidates or committees. Contributions from individuals and PACs made through these joint fundraising efforts are NOT included in the "Individual Contributions" or "Other Cmte Contributions" columns.
5. One Senate candidate has carried debts from previous elections which continue to be reflected in the "Debts Owed" column of the detailed listing and in Top 50 listings. See Lautenberg (NJ).
