Note that it is not possible to determine precise values for unitemized contributions transferred from jointfundraising committees, but information in filings suggests little if any unitemized contributions in this form.

Unitemized contributions from individuals are those which total \$200 or less in a calendar year from a single person. The maximum contribution from individuals was changed from \$20,000 per year to \$25,000 per year for the 2004 election cycle and \$26,700 in 2006, \$28,500 in 2008, \$30,400 in 2010 and \$30,800 in 2012. This table includes federal or "hard" money only.
