Federal Election Commission Advisory Opinions Statistics FY 2005-2008

The following is a compilation of statistics on advisory opinions issued for Fiscal Years 2005 through 2008. These statistics include:

- The date that a request was filed with the Commission.
- The date that an advisory opinion request (AOR) became complete.*
- The number of days from the date that a request was filed to the date that an AOR became complete.*
- The number of days it took for the requestor to make a request complete (FYs 2007-2009).
- The date(s) that the Commission voted on an AOR.
- The number of days from the date an AOR became complete to the Commission vote.
- The date that the advisory opinion (AO) was issued.
- The number of days from the date that an AOR became complete to the date that the Commission issued an AO.
- In the event of an extension of the 60-day statutory deadline, the date of the new deadline.
- The number of days from the date a request was filed to the date that the Commission issued an AO.

* The Act directs the Commission to issue an AO within 60 days of receiving a complete AOR. 2 U.S.C. 437f(a)(1). The Office of General Counsel reviews all requests for completeness. 11 CFR 112.2. If the Office of General Counsel determines that a request for advisory opinion is incomplete or otherwise not qualified, it shall within 10 calendar days notify the requesting party of the request's deficiencies. 11 CFR 112.1(d). The 60-day statutory deadline begins on the date the Office of General Counsel receives sufficient information to make the AOR complete.
