Ms. Lopez and Ms. Mahmood:

Thank you for speaking with me about your advisory opinion request on behalf of the Democratic Party of Wisconsin Federal. My understanding of the clarifying information you provided is as follows:

- 1. Under the proposal, the joint fundraising committee would distribute joint fundraising proceeds directly to the nominee if the nominee ratifies the joint fundraising agreement within 10 days of the state of Wisconsin declaring the winner of the 2022 democratic primary election. The joint fundraising committee would not distribute any joint fundraising proceeds through the nominee fund. The requestor would be amenable to modifying this approach if required to do so by the Commission, however, for example, by having the joint fundraising committee distribute joint fundraising proceeds to the nominee fund, which would then forward the proceeds to the nominee.
- 2. The second bullet on page 4 of the request should read as follows: "enter into a written

agreement with the nominee fund that identifies the joint fundraising representative and states a formula for the allocation of fundraising proceeds, which will be included in a joint fundraising notice with every solicitation for contributions."

Please send me an email that either confirms the accuracy of these statements or corrects them.

Your response may be considered to be a supplement to the advisory opinion request; if so, it will be posted on the Commission's website.
