
I write to you again on behalf of Mr. José L. Mendoza, in connection to the captioned matter.

Further to my letter to you dated July 18, 2023, Mr. Mendoza has discovered that as result of a clerical error, which occurred at the office or place of business of Mr. Juan Herrero, Finance Director of Aníbal Comisionado 2020, on August 12, 2022, contrary to his better understanding and that of Mr. Herrero's, all the information that was remitted to the FEC was related to the agreed revisions on "disbursements". Inadvertently, none of the information sent on that date from Mr. Herrero's place of business to the FEC was related to the agreed revisions, which by then had been approved by the FEC, related to the "receipts".

Upon that very recent discovery, all revised materials related to the "receipts", which Mr. Mendoza understood had been remitted to the FEC on August 12, 2022, were finally filed with the FEC on August 24, 2023 and received and accepted by the FEC system on that same date at 6:17:59 p. m. and assigned filing ID: "FEC-1723603". 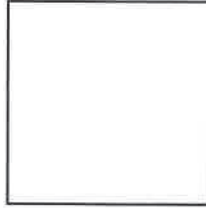
We would appreciate confirmation of receipt and review of said material from you and/or your division and of the eventual compliance by Aníbal Comisionado 2020 of said particular issue.
