Federal Election Commission Minutes of an Open Meeting March 9, 2017

Chairman Steven T. Walther called the Federal Election Commission to order in an open meeting at 10:14 A.M. on Thursday, March 9, 2017 with a quorum present.

Chairman Walther opened the meeting recognizing Lynne McFarland, the FEC's Inspector General. Chairman Walther stated that Ms. McFarland had been with agency for 40 years, 27 of them as Inspector General. He noted that Ms. McFarland was both the first ever Inspector General for the FEC and the longest serving Inspector General of any Federal agency. In honor of her retirement, the Chairman thanked Ms. McFarland for her service, and recognized her and her staff for their hard work and competence. Chairman Walther presented Ms. McFarland with a small gift. Ms. Carla Smith of the Office of the Inspector General offered remarks and appreciation to Ms. McFarland on behalf of their office.

II. AUDIT DIVISION RECOMMENDATION MEMORANDUM ON THE COLORADO REPUBLICAN COMMITTEE (CRC) (A13-12)

Chairman Walther recognized Ms. Mary Moss of the Audit Division who summarized the four Findings in the Memorandum: 1) Misstatement of Financial Activity; 2) Reporting of Apparent Independent Expenditures; 3) Recordkeeping for Communications; 4) Failure to Itemize Debts and Obligations. Ms. Moss reminded the Commission of the Audit Hearing held in this case at the Colorado Republican Committee's (CRC) request, and that the Commission granted CRC an opportunity to submit banking documentation for portions of Finding 1. She noted that no such documentation had been received from CRC to-date.

Discussion followed.

Commissioner Goodman requested time to review the matter following the discussion.

The meeting recessed at 10:34 A.M. and reconvened at 10:38 A.M. with a quorum present.
