SUBJECT: Debt Settlement Plan #22-01

Marianne Williamson for President (C00696054)

Marianne Williamson for President ("Committee") has submitted a debt settlement plan ("DSP" or "plan") for Commission approval. The DSP discloses that the Committee owes a total of \$269,648.48 to eight creditors, one of whom is the candidate. Attachment at 4. We recommend that the Commission approve the debt settlement plan because it satisfies the regulatory factors the Commission considers in evaluating such plans.

I. THE COMMISSION SHOULD APPROVE THE COMMITTEE'S DEBT SETTLEMENT PLAN

The DSP discloses that the Committee has settled debt totaling \$249,012.51 with four of its eight creditors, including the candidate.² The candidate is forgiving 100% of her loans from

personal funds totaling \$161,319.55.³ The DSP is summarized in the following chart that identifies the three non-candidate creditors listed in Part II of the plan, the amounts owed, the amounts offered in settlement, the amounts to be forgiven, and the percentage of the amounts owed to be forgiven.

The Committee disclosed that it paid in full the amounts offered in settlement to these creditors before submitting the DSP.⁴ The plan indicates that each of the creditors conditioned their settlement on the Committee's prompt payment of the agreed amount.⁵

Id. at 6-8. Since a candidate may make unlimited expenditures of personal funds to her committee, 11 C.F.R. § 110.10, the candidate may permissibly forgive her loans. Therefore, the analysis of the DSP that follows addresses only the Committee's debt to the named three creditors in Part II (Creditor Summary Information) of the DSP, as represented in the chart on this page. See Attachment at 9-17, 47-48 (DSP and Committee's August 2022 Monthly Report, respectively).

Commission regulations state that a terminating committee shall not make any payments to creditors included in a debt settlement plan until the Commission has completed its review. 11 C.F.R. § 116.7(a). Although the Committee has already paid its creditors the settlement amounts indicated in the chart above, the premature payments do not preclude the Commission from reviewing and approving the debt settlement plan. See Donovan for Congress (DSP # 16-02) (approving debt settlement plan although the committee paid creditors before the Commission completed its review); Beatty for U.S. Senate (DSP # 09-01) (same); Rudy Giuliani Presidential Committee, Inc. (DSP # 13-02) (same); DeVore for California (DSP # 11-01) (same).

A. The Debt Settlement Plan Meets the Six Factors Under Section 116.7

The Commission reviews debt settlement plans to ensure that neither excessive nor prohibited contributions result from the creation and settlement of a committee's debts. Debts Owed by Candidates and Political Committees, 55 Fed. Reg. 26,378 (June 27, 1990). The Commission considers six factors in evaluating debt settlement plans: (1) information provided by the Committee and its creditors; (2) the amount of each debt that remains unpaid and the length of time each debt has been overdue; (3) the amount and percentage of each debt that would be forgiven under the plan; (4) the total amount of debts and obligations owed by the terminating committee to all creditors, compared to the total amount of cash on hand and other amounts available to pay those debts and obligations; (5) the year-to-date expenditures and receipts of the terminating committee; and (6) whether the total percentage that was or will be repaid on any loans made by the candidate to the terminating committee is comparable to the total percentage that was or will be paid to other creditors. 11 C.F.R. § 116.7(f)(1)-(6).

Application of the Six Factors.

With respect to the first factor, the Committee must submit information that supports the DSP. 11 C.F.R. § 116.7(f)(1); see also 11 C.F.R. § 116.7(e) (listing required information). The supporting information must include information about the origination and satisfaction of the debt, including 1) the terms of the initial extension of credit, 2) the candidate's or the committee's efforts to satisfy the debts, and 3) the creditor's use of remedies to satisfy the debt. 11 C.F.R. § 116.7(e)(1)(i)-(iii).

The Committee submitted information in support of the DSP. The plan sets forth the nature of the debts the Committee seeks to settle and the terms of the initial extensions of credit. The Committee describes the L2, Inc., debt as having been incurred for the acquisition of a national voter file for which the Committee was required to pay overtime, either on a monthly or quarterly basis. In attempting to collect the debt, L2, Inc., represents that it continually reached out to the Committee requesting payment, worked with a Committee representative responsible for the campaign's debt, and negotiated terms for settling the debt. Attachment at 10.

The DSP explains that Ballot Access Management, LLC, provided nomination petition services and permitted the Committee to pay after it provided the services. Ballot Access Management, LLC, represents that it attempted to resolve the debt by asking to be paid and agreed to let the Committee pay when able. *Id.* at 13.

Financial Innovations, Inc., reportedly provided website services⁶ for which the Committee was required to pay every 30 days. Financial Innovations, Inc., states that it attempted to collect the debt by emailing periodic statements to the Committee and giving it additional time to pay. Attachment at 16; 11 C.F.R. § 116.7(e)(1)(i), (iii). The DSP also describes the efforts the Committee made to satisfy these debts. The Committee tried to pay the

The DSP itself does not describe the nature of the Ballot Access Management, LLC debt. However, the Committee's August 2022 Monthly Report identifies the services provided. *See* Attachment at 47-48.

debt by fundraising, reducing its administrative costs by laying off employees, and generating revenue by licensing lists it developed over the course of the campaign. Attachment at 9, 12, 15; 11 C.F.R. § 116.7(e)(1)(ii).

Each of these three creditors signed the DSP acknowledging that they accepted the Committee's settlement offer and affirming that their efforts to collect the debts were similar to other debt collection efforts against nonpolitical debtors and that the terms of their debt settlements with the Committee were comparable to those the creditors make with other nonpolitical debtors. Attachment at 11, 14, 17; 11 C.F.R. § 116.7(e)(2).

With respect to the second and third factors, these debts were incurred between December 31, 2019, and January 31, 2020, and the relevant information regarding the amount of each debt that remains unpaid, and the amount and percentage of each debt forgiven is summarized in the chart above. 11 C.F.R. § 116.7(f)(2)-(3).

A committee that expects to have residual funds must include in the DSP information as to how those funds will be used. 11 C.F.R. § 116.7(e)(5). Analysis of the fourth factor shows that the total amount of the Committee's debts of \$87,692.96 exceeds its available cash on hand, which was \$28,436.36 as of March 29, 2022, and that the Committee has no remaining assets to liquidate.⁷

For the fifth factor, the DSP discloses the Committee's 2022 year-to-date receipts total as \$75, and its year-to-date disbursements total as \$34,572.95. See Attachment at 4; 11 C.F.R. § 116.7(f)(5).

The sixth and final factor involves comparing the total percentage of any loans that were or will be repaid to the candidate with the total percentage that will be repaid on loans made by other creditors. 11 C.F.R. § 116.7(f)(6). As noted above, the candidate has outstanding loans to the Committee totaling \$161,319.55. The candidate, however, is forgiving this indebtedness completely. Consequently, there are no issues with respect to the candidate receiving more in the debt settlement plan than the other creditors.

Attachment at 4. The DSP included four creditors listed in Part III (List of Remaining Debts) that the Committee planned to pay in full. *Id.* at 18-19. The Committee has reported payments to those creditors for the full amounts. *See* Marianne Williamson for President, May 2022 Monthly Report, FEC Form D-P at 8-10 (May 20, 2022), https://docquery.fec.gov/pdf/448/202205209512502448/202205209512502448.pdf. In the Committee's most recent report, the Committee reports cash on hand of \$3,212.97. *See* Marianne Williamson for President, September 2022 Monthly Report, FEC Form 3P at 2 (Sept. 15, 2022), https://docquery.fec.gov/pdf/481/202209159528477481/202209159528477481.pdf.

The Committee's most recent report shows year-to-date receipts as \$278 and year-to-date disbursements as \$59,999.34, and \$3,212.97 cash-on-hand. *See* Marianne Williamson for President, September 2022 Monthly Report, FEC Form 3P at 2.

B. The Debt Settlement Plan Does Not Result in An Excessive Contribution to The Committee

We conclude that the foregoing factors weigh in favor of approving the debt settlement plan. 11 C.F.R. § 116.7(f). The information the Committee provided demonstrates that the debt owed to the creditors will be settled under the terms of the debt settlement plan, that the creditors agree to the terms of the settlement, and that there will be no residual funds. Because the requirements for the debt settlement plan have been met, we conclude that the debt settlement with the creditors would not result in an excessive contribution from the creditors to the Committee. *Id.*; *see* Debts Owed by Candidates and Political Committees, 55 Fed. Reg. at 26,378. Accordingly, we recommend that the Commission approve the debt settlement plan.

II. <u>RECOMMENDATIONS</u>

- 1. Approve the debt settlement plan filed by Marianne Williamson for President;
- 2. Approve the appropriate letter; and
- 3. Close the file.

Attached is the Amended <u>debt settlement plan (DSP)</u> filed by <u>Marianne Williamson for President (C00696054)</u> on July 8, 2022¹, along with other supporting documents relating to this matter.

The total amount of non-candidate debt currently owed by the Committee and requested for settlement in Part II of the DSP is \$42,192.96². According to the <u>2021-2022 RAD Review and Referral Procedures (Standard 19)</u>, all DSPs seeking to settle an individual debt greater than or combined debts greater than require further examination by your office.

¹ The Committee filed the <u>original DSP on April 11, 2022</u>. The Reports Analysis Division sent an <u>MS-C</u> on June 20, 2022 which requested additional information related to the DSP.

²The Committee previously paid \$45,500.00 of the \$87,692.96 in non-candidate debts owed by the Committee and disclosed in Part II of the DSP. On March 20, 2020, the Committee filed the <u>2020 March Monthly Report</u> which disclosed a \$35,000.00 payment to L2, Inc, as reported in the DSP. On May 20, 2022, the Committee filed the <u>2020 May Monthly Report</u> which disclosed a \$7,500.00 payment to Ballot Access Management, LLC, and a \$3,000.00 payment to Financial Innovations, Inc.as reported in the DSP.

All the information provided by the Committee within the DSP has been reviewed. At this time, the Committee is otherwise eligible for termination.
