SUBJECT: Status of Enforcement – Fiscal Year 2023, First Quarter (10/01/22-12/31/22)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the First Quarter of Fiscal Year 2023 (10/01/22-12/31/22). The tables that follow provide information to assist agency management in its review of the enforcement program.

In summary, at the close of the quarter, the total caseload was 198 matters — 115 active and 83 inactive. During the quarter, the Enforcement Division circulated First General Counsel's Reports ("FGCRs") in 21 matters in an average of 164 days, meeting the internal circulation goal 81% of the time. The Enforcement Division's Office of Complaints Examination & Legal Administration ("CELA") circulated 11 EPS reports this quarter. There were 11 matters pending in the investigation stage at the close of the quarter. There were also 31 case closings and the Commission assessed \$474,400 in civil penalties.
