SUBJECT:	Debt Settlement Plan #23-01 Americans for Decency and Democracy (C00756635)

Americans for Decency and Democracy ("Committee") has submitted a debt settlement plan ("DSP" or "plan") for Commission approval.<sup>1</sup> The DSP discloses that the Committee has no cash on hand, owes a total of \$50,000 to one creditor, and has offered that creditor a settlement of \$0. Attachment at 3. The \$50,000 debt represents approximately 6% of the cost of services provided by the creditor to the Committee, as the Committee repaid nearly \$800,000 to the creditor for services rendered in 2020 and 2021. We recommend the Commission approve the debt settlement plan because it satisfies the regulatory factors the Commission considers in evaluating such plans.

## I. THE COMMISSION SHOULD APPROVE THE COMMITTEE'S DEBT SETTLEMENT PLAN

## A. The Debt Settlement Plan Meets the Six Factors Under Section 116.7

The Commission reviews debt settlement plans to ensure that neither excessive nor prohibited contributions result from the creation and settlement of a committee's debts. Debts Owed by Candidates and Political Committees, 55 Fed. Reg. 26,378 (June 27, 1990). The Commission considers six factors in evaluating debt settlement plans: (1) information provided by the Committee and its creditors; (2) the amount of each debt that remains unpaid and the length of time each debt has been overdue; (3) the amount and percentage of each debt that would be forgiven under the plan; (4) the total amount of debts and obligations owed by the terminating committee to all creditors, compared to the total amount of cash on hand and other amounts available to pay those debts and obligations; (5) the year-to-date expenditures and receipts of the terminating committee; and (6) whether the total percentage that was or will be repaid on any loans made by the candidate to the terminating committee is comparable to the total percentage that was or will be paid to other creditors. 11 C.F.R. § 116.7(f)(1)-(6).

#### Application of the Six Factors.

With respect to the first factor, the Committee must submit information that supports the plan. 11 C.F.R. § 116.7(f)(1); *see also id.* § 116.7(e) (listing required information). The supporting information must include information about the origination and satisfaction of the debt, including 1) the terms of the initial extension of credit, 2) the candidate's or the committee's efforts to satisfy the debts, and 3) the creditor's use of remedies to satisfy the debt. *Id.* § 116.7(e)(1)(i)-(iii).

The Committee submitted information in support of the DSP. The plan discloses that the Committee owes 50,000 to Rally Campaigns for consulting services in 2020. Rally Campaigns represents that it extended credit based on the Committee's agreement to pay the consulting fee when it became active in the 2022 elections. Rally Campaigns agreed to delay payment from the Committee, without penalty, but states that it continued to ask the Committee's fundraiser to fundraise to settle the debt. Attachment at 6. Rally Campaigns states that it did not contact the Committee to collect the debt because the Committee did not become active in the 2022 election year, and it was aware that the Committee had not raised funds. *Id.*; 11 C.F.R. § 116.7(e)(1)(ii)-(iii).

Rally Campaigns' representative signed the plan on August 1, 2023, stating that Rally Campaigns' extension of credit to the Committee was in conformity to the usual and normal practice in its trade or industry, affirming that it does not have any political or non-political debtors with which to compare its debt collection efforts or the debt settlement terms it extended to the Committee, and acknowledging that it accepted the Committee's settlement offer of \$0. Attachment at 7; 11 C.F.R. § 116.7(e)(2).

With respect to the second and third factors, the debt totaling \$50,000 was incurred on December 16, 2020. This debt remains unpaid. Under the plan, the Committee would not pay any amount to Rally Campaigns in settlement of the debt. The proposed settlement would thus result in Rally Campaigns forgiving 100% of the debt. 11 C.F.R. § 116.7(f)(2)-(3). The \$50,000 debt represents approximately 6% of the cost of services provided by Rally Campaigns to the

Committee, based on the Committee's reported payments of \$792,534.24 to Rally Campaigns in 2020 and 2021.<sup>2</sup>

Analysis of the fourth factor shows that the total amount of the Committee's debt of \$50,000 exceeds its available cash on hand, which was \$0 as of June 30, 2023, and that the Committee has no remaining assets to liquidate.

The Committee's ability to pay its debt to Rally Campaigns Strategies is limited by the funds available to it or funds the Committee may be able to raise. The plan discloses that the Committee planned to repay the debt once it became active in the 2022 election year. Attachment at 5. The Committee did not become active in the 2022 election year and has reported raising only one contribution since December 13, 2021, totaling \$7,361.17 on March 28, 2023.<sup>3</sup> Because the Committee is not active, has received only one contribution in nearly two years, and has no other funds, we conclude that the Committee is unlikely to be able to pay the debt.

For the fifth factor, the DSP discloses the Committee's 2023 year-to-date receipts total as \$7,361.14, and its year-to-date disbursements total as \$7,454.38.<sup>4</sup>

The sixth and final factor involves comparing the total percentage of any loans that were or will be repaid to the candidate with the total percentage that was or will be repaid to other creditors. 11 C.F.R. § 116.7(f)(6). Because the Committee is an independent expenditure-only committee, there are no candidate loans in the debt settlement plan.

The Commission's debt settlement regulations do not require that a terminating committee settle its debts with all of its creditors in comparable percentage terms nor do the regulations require that a terminating committee pay a specific settlement amount. The Commission has previously approved debt settlement plans in which committees proposed 100% debt forgiveness for creditors. In Jim Gilmore for President, DSP #10-01, the terminating committee proposed 100% debt settlement with three creditors, in amounts ranging between \$5,000.00 and \$29,000.00. In Ferraro for U.S. Senate, DSP # 01-02, the terminating committee proposed such settlements with five creditors in amounts ranging from \$15,000.00 to \$100,000.00. Also, in Jim Gilmore for President, DSP #10-01, the terminating committee proposed settlements with its different creditors in percentage amounts ranging from \$3% to 100% of the debt, depending on the individual creditor.

## **B.** The Debt Settlement Plan Does Not Result in An Excessive Contribution to The Committee

We conclude that the foregoing factors weigh in favor of approving the debt settlement plan. 11 C.F.R. § 116.7(f). The information the Committee provided demonstrates that the debt owed to Rally Campaigns will be settled under the terms of the debt settlement plan, that the creditor agrees to the terms of the settlement, and that there will be no residual funds. Because the requirements for the debt settlement plan have been met, we conclude that the debt settlement with Rally Campaigns would not result in an excessive contribution from that creditor to the Committee. *Id.*; *see* Debts Owed by Candidates and Political Committees, 55 Fed. Reg. at 26,378. Accordingly, we recommend that the Commission approve the debt settlement plan.

### II. <u>RECOMMENDATIONS</u>

- 1. Approve the debt settlement plan filed by Americans for Decency and Democracy;
- 2. Approve the appropriate letter; and
- 3. Close the file.

Attached is the Amended <u>debt settlement plan (DSP)</u> filed by <u>Americans</u> for <u>Decency and Democracy (C00756635)</u> on August 7, 2023<sup>1</sup>, along with other supporting documents relating to this matter in accordance with 11 C.F.R. §116.7.

The total amount of non-candidate debt currently owed by the Committee as disclosed on the <u>2023 Mid-Year Report</u> filed on July 28, 2023 and requested for settlement in Part II of the DSP is \$50,000.00<sup>2</sup>. According to the <u>2023-2024 RAD Review</u> <u>and Referral Procedures (Standard 19)</u>, all DSPs seeking to settle an individual debt greater than for combined debts greater than require further examination by your office.


