# II. <u>DRAFT ADVISORY OPINION 2019-07</u> (continued)

Chair Weintraub recognized Mr. Joseph Wenzinger of the General Counsel's Office who presented the draft advisory opinion request from Area 1 Security, Inc. The requestor asks whether it may offer free or low-cost cyber security services to federal candidates and political committees. Drafts A and B both conclude that the proposal is impermissible because the provision of such services would result in in-kind contributions.

Chair Weintraub welcomed Mr. Daniel Petalas and Mr. Oren Falkowitz.

Mr. Petalas and Mr. Falkowitz participated in the discussion that followed including: an overview of the proposal in the requestor's original submission and subsequent comments; the credentials held by Mr. Falkowitz, the CEO and cofounder of Area 1 Security, Inc.; the pricing model proposed by the requestor; the relevance of the Microsoft Advisory Opinion (2018-11); the focus of Area 1 Security, Inc. on anti-phishing services; the history of phishing incidents in

recent federal elections; the types of entities with which the requestor works; how the needs of those entities affect the requestor's business strategy; the application of the four (4) factor pricing model used by the requestor, including the little to no cost pricing tier; the value of this research and development to the requestor; the effect of the traditional pricing threshold for groups with 5,000 people or more on smaller entities; the application of the pricing model for services provided to federal candidates and committees; the pride aspect as relates to the employee morale of the requestor; whether this exception could create a loophole in allowing corporate in-kind contributions; the possibility of submitting an amended request that better captures the situation presented by the requestor; the pay per phish pricing structure; and how the requestor's software works.

Vice Chair Petersen asked if there was interest on the Commission of having further discussion to find a way to reach consensus on a yes answer to the request. Discussion followed.

Mr. Petalas and Mr. Falkowitz participated in the continuing discussion regarding the proposed pricing model; how many and what types of organizations fall under the little to no cost pricing tier; and what a reformulated advisory opinion request might contain.

Chair Weintraub stated that the Commission looked forward to hearing further from the requestor.
