Chairman Allen Dickerson called the Federal Election Commission to order in an open meeting at 11:09 A.M. on Thursday, December 15, 2022 with a quorum present.

# I. DRAFT ADVISORY OPINION 2022-22

DataVault I by Elliot S. Berke, Esq.

Agenda Document No. 22-57-A (Draft A)

Chairman Dickerson recognized Mr. Elliot S. Berke, on behalf of the requestor. Chairman Dickerson also recognized Mr. Joseph Wenzinger of the General Counsel's Office who presented the matter.

The requestor asks whether it may create and sell non-fungible tokens ("NFTs") to political committees for use in the committees' fundraising endeavors. Because DataVault proposes to sell the NFTs in the ordinary course of business, at the usual and normal charge, and under the same terms and conditions as its nonpolitical clients, the Draft concludes that the proposals presented in the request would not result in prohibited in-kind contributions and are, therefore, permissible.

Chairman Dickerson recognized Mr. Nathaniel Bradley, the CEO of DataVault. Mr. Berke and Mr. Bradley participated in the discussion that followed.

The motion carried by a vote of 6-0 with Commissioners Broussard,

## II. DRAFT ADVISORY OPINION 2022-23

DataVault II by Elliot S. Berke, Esq.

Agenda Document No. 22-56-A (Draft A)

Chairman Dickerson recognized Mr. Wenzinger of the General Counsel's

Office who presented the matter. The requestor asks whether it may, through a
wholly-owned subsidiary, license Adio Tones, a patented technology, to political
committees for use in the committees' fundraising endeavors. Because

DataVault proposes to license Adio Tones to political committees in the
ordinary course of business, at the usual and normal charge, and on the same
terms and conditions as its non-political clients, the Draft concludes that the
proposal would not result in prohibited in-kind contributions and is, therefore,
permissible.

Mr. Bradley and Mr. Berke participated in the discussion that followed.

# III. REG 2022-06 (DISGORGEMENT): DRAFT NOTIFICATION OF AVAILIBILITY Agenda Document No. 22-59-A

Chairman Dickerson recognized Mr. Tony Buckley of the General Counsel's Office who presented the matter.

Agenda Document No. 22-59-A contains a Draft Notice of Availability for a Petition for Rulemaking submitted by Campaign Legal Center. The petition asks the Commission to amend or clarify its regulations regarding the refunding of contributions that violate the source prohibitions or amount limitations of the Federal Election Campaign Act. The notification seeks comment on whether the Commission should commence a rulemaking based on this petition. The comment period will run for 60 days following publication of the notification in the Federal Register. After the comment period has concluded, and after the comments have been considered, the Commission may decide whether to initiate a rulemaking.

Chairman Dickerson recognized Vice Chair Lindenbaum who MOVED to approve Agenda Document No. 22-59-A.

Discussion followed.

Chairman Dickerson called the vote. The motion carried by a vote of 6-0 with Commissioners Broussard, Cooksey, Dickerson, Lindenbaum, Trainor, and Weintraub voting affirmatively for the decision.
