## I. DRAFT ADVISORY OPINION 2021-13 (continued)

Acting Deputy Secretary Vicktoria Allen participated in a discussion clarifying which Advisory Opinion was called.

Chairman Dickerson welcomed the requestor Mr. Matthew Hoh and then recognized Mr. Joseph Wenzinger and Ms. Amy Rothstein of the General Counsel's Office. Mr. Wenzinger presented the draft advisory opinion request from Mr.

Matthew Hoh. The request asks whether Mr. Hoh's Veterans Administration disability benefits constitute earned income for purposes of the Commission's candidate salary regulation. Draft A concludes that the requestor's disability benefits constitute earned income and can be used to calculate the amount of any candidate salary he may receive under Commission regulations. Drafts B and B1 conclude that these benefits do not constitute earned income and, therefore, cannot be used to calculate the amount of any candidate salary he may receive.

Mr. Hoh participated in the discussion that followed.

Chairman Dickerson recognized Commissioner Weintraub who
