## I. DRAFT ADVISORY OPINION 2022-12

Ready for Ron by Lilian Rodriquez-Baz, Esq.

Agenda Document No. 22-36-A (Draft A)

Agenda Document No. 22-36-B (Draft B)

(Held over from the meetings of August 11, 2022 and August 31, 2022)

Chairman Dickerson recognized Mr. Dan Backer on behalf of the requestor. Ms. Heather Filemyr of the General Counsel's Office presented the matter.

Ready for Ron, a nonconnected hybrid PAC, asks whether it may provide to Governor Ron DeSantis, without charge, a petition containing the names and contact information of individuals who wish to encourage him to run for president in the 2024 election and to provide regular updates with the contact information of additional petition signatories through the 2024 election cycle. Draft A concludes that the requestor may not provide the names and contact information to Governor DeSantis either before or after he becomes a federal candidate because the value of the information would exceed applicable contribution limits and limits on funds used to test the waters for a federal candidacy. Draft A also concludes that the proposal is contrary to restrictions on the use of funds in a hybrid PAC's noncontribution account. Draft B concludes that the requestor may provide the names and contact information to Governor DeSantis before he begins testing the waters for a federal candidacy because neither the Act nor Commission regulations prohibit such activity, but that it may not do so after he begins testing the waters or becomes a federal candidate. Draft B also concludes that the proposal is contrary to restrictions on the use of funds in a hybrid PAC's noncontribution account if the information is provided after Governor DeSantis begins testing the waters or becomes a federal candidate.

Mr. Backer participated in the discussion that followed.

Chairman Dickerson recognized Vice Chair Lindenbaum who

MOVED to approve Agenda Document No. 22-36-B, which is Draft B.

Discussion continued.

Chairman Dickerson called the vote. The motion failed by a vote of 2-4 with Commissioners Cooksey and Trainor voting affirmatively for the motion.

Commissioners Broussard, Dickerson, Lindenbaum, and Weintraub dissented.

Discussion continued.

Chairman Dickerson recognized Commissioner Weintraub who

MOVED to direct the Office of General Counsel to prepare a response that answers the parts of the question where the two drafts overlap and then says the Commission couldn't agree on the rest.

The motion carried by a vote of 4-2 with Commissioners Broussard,

Dickerson, Lindenbaum, and Weintraub voting affirmatively for the decision.

Commissioners Cooksey and Trainor dissented.

Mr. Backer and Ms. Filemyr participated in the continuing discussion.

### II. DRAFT ADVISORY OPINION 2022-17

Warren Democrats by Kate Sawyer Keane, Esq. and Sarah N. Mahmood, Esq.

<u>Agenda Document No. 22-44-A1 (Revised Draft A)</u> (Submitted Late)

Chairman Dickerson recognized Mr. Joshua Blume of the General Counsel's Office who presented the matter.

Warren Democrats, Inc. is the principal campaign committee of Senator Elizabeth Warren. The committee asks whether it may use campaign funds to pay for reasonable cybersecurity measures to protect the home network of the Senator, which connects to her electronic devices, as well as to those of household members and to visitors to the household. The drafts conclude that the committee may use campaign funds for this purpose because it would constitute an ordinary and necessary expense incurred in connection with the Senator's duties as a federal officeholder. Revised Draft A does not differ substantively from Draft A but contains some technical changes.

Chairman Dickerson recognized Ms. Sarah Mahmood on behalf of the requestor and then recognized Vice Chair Lindenbaum who

MOVED to approve Agenda Document No. 22-44-A1, which is Revised Draft A.

The motion carried by a vote of 6-0 with Commissioners Broussard,

Cooksey, Dickerson, Lindenbaum, Trainor, and Weintraub voting affirmatively for
the decision.
