I. DRAFT ADVISORY OPINION 2023-02

Humana, Inc. by Joseph M. Birkenstock, Esq.

Agenda Document No. 23-05-A (Draft A)

Chair Cooksey stated for the record, "Chair Lindenbaum is recused from this matter."

Vice Chair Cooksey recognized Mr. Joseph Birkenstock who appeared on behalf of the requestors. Vice Chair Cooksey then recognized Ms. Cheryl Hemsley and Mr. Robert Knop of the General Counsel's Office. Ms. Hemsley presented the matter. The request asks whether Humana Inc. PAC is still affiliated with their former subsidiary, KAH Hospice Company, Inc. and KAH Hospice Company, Inc. PAC, having spun-off KAH Hospice in August of 2022. The draft first notes that the entities are not per se affiliated and then goes on to consider the facts in light of the affiliation factors set forth in the regulations. After analyzing the relationships between the two companies and their SSFs, the draft determines that the entities are no longer affiliated.

Mr. Birkenstock participated in the discussion that followed.

Vice Chair Cooksey recognized Commissioner Dickerson who
